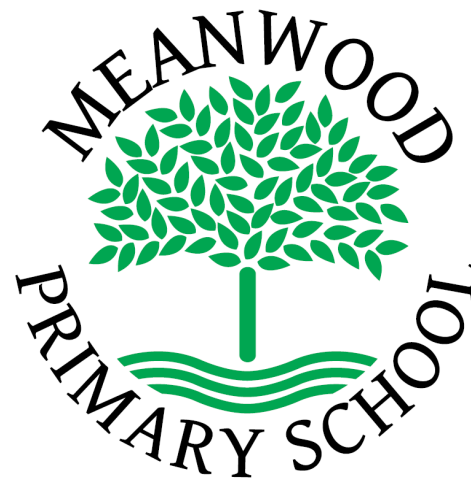

Responsible Internet Use Rules

1. I will not give out personal information such as my address, telephone number, school address telephone number.
2. I will not give out my passwords to anyone (even my best friends) other than my teacher/parents.
3. I will only access the websites that I am told to by my teacher.
4. I will tell a school adult right away if I come across something that makes me feel uncomfortable.
5. I will talk with my teacher's/parents about posting pictures of myself or others online and will not post any pictures of my friends online.
6. I will never agree to get together with someone I "meet" online.
7. I will not respond to any messages that are mean or in any way make me feel uncomfortable. It is not my fault if I get a message like that. If I do I will tell my parents/teachers right away.
8. I will not download or install any software or do anything that could possibly hurt our computers or mobile devices or jeopardize my school's privacy.
9. I will be a good online citizen and not do anything that hurts other people or is against the law.
10. I will help others to understand how to have fun and learn things online and teach them things about the Internet, computers and other technology.

Dear Parent/Carer,

We would like to welcome you to Meanwood Primary School and hope that your child is really happy at our school. If you have any problems, please speak to your child's class teacher in the first instance.

We have produced this booklet so that you know all about our school but also for you to be able to indicate if you would like your child involved in certain activities and an opportunity to let us know any medical issues or allergies they may have. You will receive a new copy of this booklet at the beginning of each year so that you can update us but please don't hesitate to contact us if something changes in the mean time.

- If your child requires us to administer medication that is prescribed by a doctor you will need to complete a form at the office.
- If your child needs an inhaler, an asthma form needs to be completed at the office and the inhaler and spacer given to your child's class teacher.
- We would like all our children to wear full school uniform including black shoes, not trainers please and a plain white top and dark shorts for PE.
- Dinner money is payable weekly at a cost of £2.10 per day. If you are more than 1 week in arrears your child will be asked to bring a packed lunch until the account is paid. If you would like to change from packed lunch to dinners or vice versa 2 weeks notice is required. If your child is in Reception, Year 1 or Year 2 they qualify for Universal Free School meals and will received free meals regardless of circumstances. Please speak to someone in the office if you think that you qualify for free school meals. You can pay for school meals online or by cash and card at the school office.

Please return this booklet to your child's class teacher and a copy will be on the school website for your information.
