

#### Pupil Premium COVID Summary Statement November 2021

FCAT has a total PP allocation of around £2.8 million which of course is shared around all the Academys at about £1000 per PP child with PP percentages ranging from about 10% to 70%. In a normal year the PP spending would be reviewed in terms of its impact on a variety of measures including Educational outcomes (particularly in Year 6 and 11), Attendance figures and exclusion data. This year we have had no nationally comparable educational outcomes. In addition, our Academys for a lengthy period of time have not been open to all year groups, so comparisons of attendance and exclusions are difficult to make, between one year and another.

One could argue that the best 'Outcome' that all our Academys contributed to was to enable our students on FSM to be fed properly, with all our Academys involved in a variety of methods of providing food for children, all of which is very much at the heart of the Trust's mission to provide for the public good.

All our PP statements and materials will have been reviewed, but this year they will not have been fully evaluated for obvious reasons. Each Academy will produce a new 2021-21 PP statement of action, which in all probability will be mainly based on the 2019-20 version.

Last year the DCEO Secondary completed a detailed summary of PP spending which was shared at Directors. This document indicated what proportion of monies was spent on particular areas, spending on additional staffing being the highest commitment. All our Headteachers are aware of the Educational Endowment Foundation Guide to the Pupil Premium. This highlights that spending should be spent in three areas: -

- 1. First quality teaching
- 2. Targeted academic support
- 3. Wider strategies (To support with behaviour, attendance, welfare and other areas)

We feel reassured that all our PP spending follows our core values. Clearly on return to full reopening in September, Head teachers have utilised some of this money and spent some reserves to provide some additionality for all students, but particularly PP children These are some of the areas where we have looked to support all our children: -

- Additional laptops, much funded through the national scheme
- Food vouchers
- Additional counselling
- Additional support for Remote Learning
- Home tutoring
- Additional attendance support
- More home visits

This is not an exhaustive list. However, to conclude all our Heads and Executive Headteachers have shown a great commitment to PP children throughout this period in the nation's history

#### What is Pupil Premium?

Pupil Premium Grant provides funding for two separate policies:

- raising the attainment of disadvantaged pupils of all abilities to reach their potential
- supporting children and young people with parents in the regular armed forces

#### Funding for 2021-2022

In the 2021-2022 financial year, pupil premium funding will be:

- £1,345 for each primary-aged pupil eligible for Free Academy Meals
- £2,345 for each Looked After and Post Looked After Child

At Mereside Primary Academy, we use Pupil Premium funding effectively to support raising the attainment of disadvantaged pupils and closing the gap with their peers. We will use effective programmes of intervention in teaching and learning, pastoral support and through our enrichment and entitlement provision. Pupil standards are evaluated so funding can be devolved to enhance the provision for pupils with complex needs and multiple vulnerabilities both academically and emotionally in order to close the gap in progress and attainment.

#### Pupil Premium Reviews

As of January 2021, approximately 65% of our pupils are eligible for the Pupil Premium Grant and therefore continuous review and evaluation of how this funding is impacting on our pupils is important to us. We review and evaluate our previous years use and impact of Pupil Premium annually. With this, we then also consider what may be required for our pupils for the following year in line with our Academy Improvement Plan and Strategy for supporting outcomes for pupils from disadvantaged backgrounds.

## Additional aims with our 2021/2022 plan includes

- To ensure there are robust systems for Child Protection and Safeguarding using CPOMs in order to support and protect our must vulnerable children particularly those who are in receipt of the funding.
- To narrow the gap in attainment of these pupils identified as pupil premium and those who are non-pupil premium in reading, writing and maths through first quality teaching, interventions and precision learning.
- Integrating and using our Post COVID Recovery plan as required to support catch up programmes and intervention strategies are identified as required and actions put in place to combat challenges to pupils learning.
- Enhance the learning experiences and opportunities across the Academy in order to overcome gaps in learning and ensure better than expected progress.
- Enhance expertise within Academy in order to meet the global needs of all children and overcome barriers to learning.
- Individual personal action plans with detailed individual interventions which include additional reading, speech and language, social skills, individual support, extra maths group teaching, self-esteem and self-awareness, feelings and friendship skills.
- Continues Professional Development for all staff, such as on sensory processing and new behaviour strategies.
- Enhance rigorous and supportive systems for behaviour management in order to support and nurture the most vulnerable children and families.
- Enhance parental engagement in the life of the Academy, targeting vulnerable and pupil premium families.
- Continue to develop links with appropriate outside agencies in order to meet the needs of children and families.
- Liaise and work in a coordinated way with the new SEND publication in order to meet the learning needs of the most vulnerable children and those in receipt of the funding.
- Enhance and develop the pastoral provisions in place in Academy in order to provide additional nurturing support for vulnerable children as well as those in receipt of the funding. ie counselling services.
- Widen pupils' experiences both in and outside of Academy in order to develop and nurture talents and life experiences.

## How we will measure the impact of the pupil premium

Our Academy has a Pupil Premium Lead, Mrs Jane Walpole, who along with all the Senior Leadership Team will monitor and evaluate the impact of our Pupil Premium Funding on the achievement of our pupils.

Individual monitoring on a half termly basis, along with detailed case studies, for progress through pupil progress meetings, re planning of targets and next steps as necessary and adapting intervention programmes and precision learning. These will be put on to CPOMs and monitored by the Senior Leadership Team and SENDCo/Inclusion Lead and the Academy Council to evaluate the impact on attainment and progress.

Periodic reports will be produced for the Academy Council which will detail progress to date, evaluated data, impacts and further areas of improvements. These will allow for challenge and discussion for the Pupil Premium Lead and SLT on overall outcomes for our pupils that are eligible for the funding.
