#### **Vision**

Together, we are building a community of creative successful life long learners. We challenge ourselves to achieve whilst sustaining spiritual, moral, emotional and economic well being. **The world is our classroom!** 

#### Introduction

The Early Years Foundation Stage (EYFS) applies to the learning and development of all children from birth to the end of the Reception Year.

Early childhood is the foundation on which children build the rest of their lives. It is not just a preparation for the next stage but is vitally important in itself.

Learning for children is a rewarding and enjoyable experience in which they explore, investigate, discover, create, practice, rehearse, repeat, revise and consolidate their developing knowledge, skills, understanding and attitudes. During the Foundation Stage, many of these aspects of learning are brought together effectively through playing and talking.

# **Aims and Objectives**

At Milverton Community Primary and Pre-School we aim to provide the highest quality care and education for all our children thereby giving them a strong foundation for their future learning. We create a safe and happy environment with motivating and enjoyable learning experiences that enable children to become confident and independent learners. We value the individual child and work alongside parents and carers to help every child reach their full potential.

As outlined in the 'Statutory Framework for Early Years Foundation Stage':

'Every child deserves the best possible start in life and the support that enables them to fulfil their potential. Children develop quickly in the early years and a child's experiences between birth and age five have a major impact on their future life chances.'

### **Statutory Framework of EYFS**

At Milverton Community Primary and Pre-School we follow the Statutory Framework for Early Years Foundation Stage 2021. We adhere to the four guiding principles that shape practice within Early Years settings:

- Every child is a **unique child**, who is constantly learning and can be resilient, capable, confident and self-assured;
- Children learn to be strong and independent through positive relationships;
- Children learn and develop well in enabling environments, in which their experiences
  respond to their individual needs and there is a strong partnership between practitioners and
  parents/ carers;
- Children develop and learn in different ways and at different rates.

As part of our practice we:

- Provide a balanced curriculum, based on the EYFS, across the seven curriculum areas, using play as the vehicle for learning;
- Promote equality of opportunity and anti-discriminatory practice.

- We provide early intervention for those children who require additional support;
- · Work in partnership with parents and carers;
- Plan challenging learning experiences, based on the individual child, informed by observation and assessment and by the children's own ideas and interests;
- Provide opportunities for children to engage in activities that are adult-initiated, child-initiated and adult supported;
- Provide a secure and safe learning environment indoors and outdoors.

# **Early Years Foundation Stage Curriculum**

We plan an exciting and challenging curriculum based on our observation of children's needs, interests, and stages of development across the seven areas of learning to enable the children to achieve the Early Learning Goals. We use Development Matters to support our planning.

All seven areas of learning and development are important and interconnected.

Three areas are particularly crucial for igniting children's curiosity and enthusiasm for learning, and for building their capacity to learn, form relationships and thrive, both in the EYFS and into Key Stage 1. These three areas are the **prime** areas:

- Communication and Language
- Physical Development
- Personal, Social and Emotional Development

Children are also supported through the four **specific** areas, through which the three prime areas are strengthened and applied:

- Literacy
- Mathematics
- Understanding the World
- Expressive Arts and Design

In planning and guiding children's activities, practitioners must reflect on the different ways that children learn and reflect these in their practice.

Three characteristics of effective teaching and learning are:

- 1. Playing and exploring children investigate and experience things, and 'have a go'.
- 2. Active learning children concentrate and keep on trying if they encounter difficulties.
- 3. **Creating and thinking critically** children have and develop their own ideas, make links between ideas and develop strategies for doing things.

Children are provided with a range of rich, meaningful first-hand experiences in which they can explore, think creatively and be active. We aim to develop and foster positive attitudes towards learning, confidence, communication and physical development.

Children will engage in whole group and small group activities alongside their independent learning. The curriculum is delivered using a play-based approach as outlined by the EYFS framework: 'Each area of learning and development must be implemented through planned, purposeful play and through a mix of adult-led and child-initiated activities'.

We plan a balance between children having time and space to engage in their own child-initiated activities and those which are planned by adults. During children's play, the adults interact when appropriate to stretch and challenge them further.

In planning and guiding children's activities, we reflect as practitioners on the different ways that children learn and build these into our practice. We create a stimulating learning environment to encourage children to free-flow between inside and outdoors as far as possible.

#### **Observation and Assessment**

As part of our daily practice we observe and assess children's development and learning to inform our future plans. We record our observations in a variety of ways. 2 Year Old checks are carried out by key workers in pre-school and overseen by the pre-school SENDCo. At the end of pre-school, key workers complete transition forms assessing the child's level of development as 'on track' or 'not on track', ready for starting school.

At the end of the reception year children are assessed against the expected level of development knows as the Early Learning Goals (ELGs). These are the knowledge, skills and understanding children should have at the end of the academic year in which they turn 5. Our reception class teachers make a holistic, best fit judgement about a child's development and their readiness for year 1. These judgements are made using the teacher's knowledge of the child and their own expert professional judgement.

# Safety including Safeguarding and Welfare Requirements

The safety and welfare of our children is paramount at Milverton Community Primary and Pre-School. We have robust policies and procedures in place to ensure their safety.

Within Pre-School and the reception class we provide a safe and secure environment and provide a curriculum which teaches children how to take risks, follow rules and stay safe. We comply with the welfare requirements set out in the Statutory Framework for Early Years Foundation Stage and understand that we must:

- Promote the welfare of all children;
- Promote good health;
- Manage behaviour effectively and appropriately;
- Ensure all adults working with children are suitable to do so;
- Ensure that the environment is safe and all equipment and furniture is fit for purpose;
- Ensure all children have a challenging and enjoyable learning experience.

We promote the good health of the children in our care in numerous ways, including the provision of nutritious fruit snacks, access to water throughout the day, allocating significant time for physical development and following set procedures when children become ill or have an accident.

Staff and visitors are prohibited from using their mobile phones in our classrooms, only the school cameras / iPads are used to photograph children and children must be appropriately dressed in photographs.

Milverton Community Primary and Pre-School has robust systems in place to ensure that all practitioners who have regular contact with children are suitable for their role.

The EYFS staff ALL hold the Paediatric First aid qualification, which is a statutory requirement of the EYFS.

The Child Protection Policy is in place to ensure the safety of all stakeholders at Milverton Community Primary and Pre-School. Backing up this policy is a dedicated safeguarding team. Staff have access to the 'My Concern' safeguarding system to log any concerns regarding any aspects of safeguarding and behaviour. All staff are vigilant in reporting concerns.

#### Inclusion

We value all our children as individuals, irrespective of their ethnicity, culture, religion, home language, background, ability or gender. We plan a curriculum that meets the needs of the individual child and support them at their own pace so that most of our children achieve the Early Learning Goals.

We strongly believe that early identification of children with additional needs is crucial in enabling us to give the child the support that they need and in doing so, work closely with parents/carers and outside agencies. We have a qualified SENDCo (Mrs Kate Lewis) who has the National Award for SEND coordination and leads this area for the school setting and liases with Mrs Rachel Andrews, our pre-school SENDCo.

#### The Role of Parents & Carers

We recognise the central importance of parents/carers as children's first educators. We believe they have a significant role to play in the lifelong education of their child. We strive to create and maintain partnerships with parents/carers as we recognise that together, we can have a significant impact on a child's learning. We welcome and actively encourage parents to participate confidently in their child's education and care in numerous ways.

- Holding getting to know you visits prior to the child starting pre-school.
- Holding information evenings before the children start school;
- Talking to them about their child's interests and needs during our introductory sessions in school and pre-school;
- Being welcoming and approachable and having an open-door approach for parents to voice concerns/ask questions;
- Inviting them to a parent consultation in the Autumn and Spring Terms to discuss how their child has settled and share progress and next steps for learning;
- Valuing parents' contributions to learning journeys;
- Encouraging parents to read with their child at home and make comments in their reading record books;
- For pre-school children's parents we provide a noticeboard highlighting the experiences the children have been enjoying daily;
- For reception children's parents we provide curriculum planning overviews for each topic, each term, highlighting how they can support their child at home;
- Delivering a phonics and maths presentation for reception parents;
- Welcoming parents as volunteers into our school;
- Providing reception class parents with an annual mid-year report and an end of year summary report detailing achievements and their child's EYFS profile;
- We also draw on our links with the community to enrich children's experiences by taking them on outings and inviting members of the community into our setting to talk about their lives, work and experiences.

#### **Transitions**

Transitions are carefully planned for and significant time is given to ensure continuity of learning and care. At times of transition, we acknowledge the child's needs and establish effective partnerships with those involved with the child and other settings. Children attend a number of introductory sessions to develop familiarity with the settings and practitioners. Our Reception staff also visit the local nurseries and preschools in return, to familiarise themselves with the children.

Parents/carers are encouraged to take up the offer of a one to one welcome meeting with the reception class teacher at the beginning of September. This is a valuable time to talk 1:1 with them and answer any concerns/queries they may have.

At the end of the EYFS, our Reception teachers meets with the Year 1 teachers to liaise with them and discuss the individual children and their specific needs. The children's assessment data and maths and writing books are sent with them to Year 1 so that their new teachers are able to plan for their 'next steps in learning' from the moment they enter their new class. Children spend a number of sessions towards the end of the school year in the Year 1 classroom OR with the Year 1 teachers in the Reception Class to ensure that they are familiar and comfortable with their new teachers and are 'next year ready'.

# **Monitoring of the EYFS**

We are committed to providing the best possible experiences for our children. The EYFS Coordinator (Mrs Katy Smith) is responsible for monitoring provision, teaching and learning and children's progress across the pre-school and reception class. Information is shared with the Headteacher, Pre-school Lead Practitioner, and the whole early years team as appropriate and any necessary actions are taken.

All adults in the early years team have a key role in children's learning and development. Therefore, they are required to be knowledgeable and skilled in the EYFS curriculum. Any training needs for existing or new members of staff are identified and addressed as part of performance management targets.
