This policy outlines the framework for Moorfield Primary School to meet its duties and obligations to provide a high-quality education to all of its pupils, including pupils with special educational needs and/or disabilities.

About us

At Moorfield we are committed to providing an appropriate and high-quality education to all the children in our school. We believe that all children, including those identified as having special educational needs have a common entitlement to a curriculum with breadth and depth, which is accessible to them, and to be fully included in all aspects of school life.

In our school every teacher is a teacher of every child, including those with SEND.

The person responsible for managing our SEND provision is Mr Gareth Swire (SENDCo) who has completed the National Award for SEND.

Mr Swire is a member of the Senior Leadership Team and can be contacted through the school office.

Aims and Objectives

We have three school aims which are uppermost in our minds when we work with children who have special educational needs:

- To ensure all children are given equal access to the curriculum and to raise their achievements.
- To encourage children to become independent learners with enquiring minds and a desire to learn.
- To encourage children to strive for excellence in all they do.

Our Objectives:

1. To identify and provide for pupils who have special educational needs and additional needs.
2. To work within the guidance provided in the SEND Code of Practice.
3. To operate a “whole pupil, whole school” approach to the management and provision of support for special educational needs.
4. To provide support and advice for all staff working with special educational needs pupils.
5. To provide a Special Educational Needs and Disabilities Co-ordinator (SENDCo) who will work in line with the SEND Policy.

Areas of SEND

At Moorfield Primary School we make provision for pupils with the following four areas of need as outlined in the SEND Code of Practice:

- **Communication and interaction**
- **Cognition and learning**
- **Social, emotional and mental health difficulties**
- **Sensory and / or physical needs**

The purpose of identifying the area of need is to allow the school to establish what action the school needs to take and not to fit a pupil into a category. We will identify the needs of our pupils by considering the needs of the whole child and not just the special educational needs of the child.

Identifying Special Educational Needs

The purpose of identifying the area of need is to allow the school to establish an appropriate course of action and not to fit a pupil into a category.

We recognise the benefits of identifying need at the earliest point so that we can make effective provision to improve long-term outcomes.

Needs may be identified by a number of indicators:

- Whole school tracking data
- Teacher assessments and tests
- Concerns raised by class teaching staff
- Concerns raised by parents
- Concerns raised by child
- Information received from pre-school settings and from previous schools if pupils transfer
- Information received from other services (e.g. health care)

A graduated approach to SEND support

Within our school, teachers deliver quality first teaching which allows most children's needs to be met. This can be through a variety of teaching methods, resources and opportunities. The class teacher is responsible and accountable for the progress and development of all pupils in their class, including where pupils access support from teaching assistants or any specialist staff.

If a child's needs are not being met by first quality teaching, it may be appropriate to offer a more targeted or individualised approach to their learning. This may include interventions available within school, but may also include interventions and advice provided by external agencies, such as the Inclusion Service and Educational Psychology.

At this point the class teacher, working with the Inclusion Lead, will hold a meeting with the child and their parents/carers, class teacher and any other adult involved in the child's education. At these meetings, everyone will be able to share any concerns and successes. We look at all the information we have about the child, including assessment levels and children's progress. It may be deemed appropriate to continue monitoring your child's progress, in response to first quality teaching or for your child to be put on our SEND register.

There is a cycle of **Assess, Plan, Do** and **Review** for any child before we "enter" a pupil on our SEND register.

1. Assess - what needs have been identified for you child?

Before a child is identified as having SEND the class teacher, working with the Inclusion Lead, will hold a meeting with the child and their parents/carers, class teacher and any other adult involved in the child's education. At these meetings, everyone will be able to share any concerns and successes. We look at all the information we have about the child, including assessment levels and children's progress.

2. Plan - what will we put in place to meet these needs?

Based on the children's needs any interventions or adjustments which will be made for the child will be discussed and explained. If appropriate, the Inclusion Lead will ask for help, support and guidance from specialists such as the Inclusion Service and Educational Psychologists.

3. Do - we will enact our plans for a set period of time - at least one full term.

The child will receive any additional adjustments or interventions. The child's response to this will be monitored. Class teachers remain responsible for all pupils even when they are working with other staff or specialists. The Inclusion Lead will support the class teacher in further assessment of the child's strengths and weaknesses.

4. Review - has the child responded to the action taken?

Children's responses to the intervention will be reviewed and any progress will be examined. Support may need to be adjusted after considering progress made and the views of the child and their parents. If, after good quality personalised teaching or interventions for a significant period of time, a child does not make adequate progress they may then be identified as having SEND.

Parents/carers and children are fully involved in this process and are welcome to speak to the class teacher and Inclusion Lead at any time.

Managing pupils needs on the SEND register

The SEND support for existing pupils also follows the **Assess, Plan, Do** and **Review** cycle:

- Targets are set with the child and parents/carers at a meeting with the class teacher and also the inclusion lead if requested. These are recorded on a SEND individual learning support plan.
- Any additional provision will be discussed, recorded on the child's provision map and given to parents/carers. The support plan and provision map will be added to throughout the year so that the full picture of provision is clear.

- The SEND support plans are monitored by the class teachers and the Inclusion Lead to check their effectiveness and to allow for continual review and improvement of provision for all pupils.
- Class teachers are responsible for ensuring that the targets are worked towards as described on the support plan.
- The short term targets are reviewed twice a year with parents/carers.

Education Health Care Plans

If your child's needs are complex and/or severe we may suggest that we ask Stockport Authority to carry out an Education Health and Care (EHC) Assessment.

Experts and people involved in your child's education will be asked about your child's needs and what should be done to meet them. An EHC plan will set out what your child's needs are and how they should be met. An EHC plan brings your child's education, health and social care needs into a single, legal document.

If the council decides not to write an EHC plan it will explain why. EHC plans are reviewed every year and we have Pupil Centred Reviews at our school.

You may have heard of "Statements" in the past. "Statements of special educational needs" have now been replaced by EHC plans since 1st September 2014. The transfer of existing statements to EHC plans will be a gradual process over the next three years and will usually be carried out at transition stages e.g. from KS2 to KS3.

Criteria for exiting the SEND register

Children who are identified as having a SEND may not need to be on the SEND register for the whole time they are with us. If a child is making good progress we may recommend that they are removed from the SEND register.

Supporting Pupils and Families

We can help you complete forms, write letters/emails or talk through anything you are concerned about. Sometimes we will complete an Early Help Assessment (EHA) to support the whole family. Please speak to Mr Swire (Inclusion Lead) in the first instance.

Arrangements for Accessing Assessments

For testing, especially in Year 6, we make sure that children with special educational needs have the necessary support which they would normally have in the classroom situation e.g. a scribe, extra time or a reader.

Transition

For Year 6 children moving on, we have good, established relationships with our link high schools. The high school SENDCo or key stage manager will contact the school and key information is shared with them. Our Year 6 children have transition days in their new school before they move on. Sometimes, a child may require more transition visits to make the change of class/school easier. This is something we do dependent on the needs of the child whatever their age.

Supporting pupils at school with medical conditions

Our school recognises that pupils at school with medical conditions should be properly supported so that they have full access to education, including school trips and physical education. Some children with medical conditions may be disabled and where this is the case the school will comply with its duties under the Equality Act 2010.

Care plans for illnesses are written by a medical professional with key school staff and shared as necessary. Some staff are trained to carry out specific medical tasks such as administering an Epipen. All higher level teaching assistants (HLTAs) and teaching assistants (TAs) are trained in First Aid. We ensure that all training is kept up to date.

If your child has a medical condition such as an allergy to nuts, asthma, diabetes or epilepsy it is important that you tell us about it. We will meet with you to discuss your child's health needs and do all we can to support your child. It is very important that your contact information is kept up to date as in an emergency we will need to contact you.

Some children with a medical condition may also have a statement or Education, Health and Care (EHC) plan which brings together health and social care needs, as well as their special educational provision and the SEND Code of Practice (2014) is followed.

Training and Resources

In order to maintain and develop the quality of teaching and provision to respond to the strengths and needs of all pupils, all staff are encouraged to undertake training and development. We make good use of the Inclusion Service and seek advice and training from them when we feel it is necessary.

Mr Swire (Inclusion Lead) regularly attends the local authority SENDCo network meetings in order to keep up to date with local and national changes in SEND.

Roles and responsibilities

The SEND Governor is Georgina Facer.

Storing and managing information

SEND Support plans and other relevant documents are kept on our electronic staff shared network.

Accessibility

Our school is on one level with ramped access to the school office. There are wheelchair accessible entrance doors for the office, to our classrooms and to the playground. We also have an accessible toilets and further provision in the Resource Base.
