Home-School Agreement of Partnership

- give you early notice of any concerns we may have about learning, behaviour or relationships
- seek in every way to give your child an excellent education, both academic and social.

The School will aim to:

- > set high standards, and provide a quality education for your child
- provide quality teaching and learning opportunities which will support the individual needs of your child
- provide a safe, caring, stimulating environment, where your child feels valued as an individual
- > encourage your child to achieve his or her potential in all aspects of school life
- care for your child as a valued member of the school community, irrespective of gender, race or religion
- maintain a code of conduct which fosters a caring, secure and disciplined environment
- provide a broad and balanced curriculum for all children in line with the National Curriculum and RE & RHE statutory guidelines
- provide children with suitable tasks to do at home as appropriate to their age and/or ability
- > meet with parents to discuss individual concerns
- keep parents and guardians informed about any changes in the policies of the school, and about general school matters
- > extend quality care to everyone connected with the school
- communicate timely and appropriately via text, letter, email and the school web site with the goal of all communication becoming paperless.

- take advantage of the opportunities offered for you to learn about the teaching and learning policies of the school

- o support all school and federation policies
- check notice boards/web site regularly and help the school work towards paperless communication

- o refrain from posting defamatory messages/comments on any social media platform
