

# Year 6 Rivers Trip

Dear Parent,

As part of the Rivers topic that Year 6 study this term, we have arranged a field trip to Vallis Vale with the Earth Science Centre. The children will have an opportunity to undertake a variety of fieldwork tasks including data collection, sketching and dipping for wildlife within the river. **There is no charge for this trip.**

The children will need to wear their school shirts and sweatshirts, but may wear a different pair of comfortable trousers (no jeans as they will not dry once wet!) and trainers or comfortable shoes to walk in. They will need to bring a waterproof coat and spare socks and trousers. As they will be standing in the water for part of the fieldwork, they will need to bring a pair of tall wellies in a carrier bag. Ankle wellies will restrict how far into the river they can go without getting wet. The children will also need to bring a packed lunch (unless supplied by the school) and any medication that they might need during the day. Please get in touch as soon as possible if your child is not able to walk to Vallis Vale and back.
