



# Special Needs and Disability Policy 23/24

## Aims and objectives

Our special educational needs and disabilities (SEND) policy aims to:

- Make sure our school fully implements national legislation and guidance regarding pupils with SEND including the SEN Code of Practice
- Set out how our school will:
  - Support and make provision for pupils with special educational needs and disabilities
  - $_{\odot}\,$  Provide pupils with SEND equal opportunities to access all aspects of school life
  - $\circ$  Help pupils with SEND fulfil their aspirations and achieve their best
  - Help pupils with SEND become confident individuals living fulfilling lives
  - $\circ$  Help pupils with SEND make a successful transition into adulthood
  - Communicate with pupils with SEND and their Parents/Carers and involve them in discussions and decisions about support and provision for the pupil
- Explain the roles and responsibilities of everyone involved in providing for pupils with SEND
- Communicate with, and involve, pupils with SEND and their Parents/Carers in discussions and decisions about support and provision for the pupil
- Make sure the SEND policy is understood and implemented consistently by all staff

## Vision and values

Portland School is a 3-16 provision for 140 children with social emotional mental health needs, as their primary area of need on their Education, Health and Care Plan. Pupils may also have autism, moderate learning difficulties, sensory needs, anxiety and physical, visual or hearing needs. Portland School is part of the Shaw Academy Trust. All students who attend Portland School have an Education, Health and Care Plan.

Portland School's success comes from our ethos to 'Provide every child with the steps to a brighter future'. We support our students to develop valuable skills and attitudes that prepare them for adulthood, including in our core values of;

- 1. Respect
- 2. Mental Toughness
- 3. Independence
- 4. Responsibility
- 5. Team Approach
- 6. Belonging

We expect all of our staff to deliver high quality, stimulating and dynamic lessons, where every teacher is a consistently good teacher. We expect all students to be challenged and make good progress in their learning.

Students of all ability levels will be given equal opportunities to achieve their full potential. Our purpose is to create a learning environment which fosters motivation and allows students to feel safe and flourish. We aim to empower our students to understand how to learn as well as striving to teach them what to learn.

## Legislation and guidance

This is based on the statutory <u>Special Educational Needs and Disability (SEND) Code of</u> <u>Practice</u> and the following legislation:

- <u>Part 3 of the Children and Families Act 2014</u>, which sets out schools' responsibilities for pupils with SEND
- <u>The Special Educational Needs and Disability Regulations 2014</u>, which set out local authorities' and schools' responsibilities for education, health and care (EHC) plans, SEN coordinators (SENCOs) and the special educational needs (SEN) information report
- The <u>Equality Act 2010</u> (section 20), which sets out the school's duties to make reasonable adjustments for pupils with disabilities
- The <u>Public Sector Equality Duty</u> (section 149 of the Equality Act 2010), which set out the school's responsibilities to eliminate discrimination, harassment and victimisation; and
- advance equality of opportunity and foster good relations between people who share a protected characteristic (which includes having a disability) and those who don't share it
- The <u>Governance Handbook</u>, which sets out governors'/trustees' responsibilities for pupils with SEND
- The <u>School Admissions Code</u>, which sets out the school's obligation to admit all pupils whose education, health and care (EHC) plan names the school, and its duty not to disadvantage unfairly children with a disability or with special educational needs

## Inclusion and equal opportunities

At our school we strive to create an inclusive teaching environment that offers all pupils, no matter their needs and abilities, a broad, balanced and challenging curriculum. We are committed to offering all pupils the chance to thrive and fulfil their aspirations.

We will achieve this by making reasonable adjustments to teaching, the curriculum and the school environment to make sure that all pupil are equally included in all aspects of school life.

## Definitions

#### **Special Educational Needs**

A pupil has SEN if they have a learning difficulty or disability that requires special educational provision to be made for them.

They have a learning difficulty or disability if they have:

- A significantly greater difficulty in learning than most others of the same age, or
- A disability which prevents or hinders them from making use of facilities of a kind generally provided for others of the same age in mainstream schools

**Special educational provision** is educational or training provision that is additional to, or different from, that made generally for other children or young people of the same age by mainstream schools.

#### Disability

Pupils are considered to have a **disability** if they have a physical or mental impairment that has a substantial and long-term adverse effect on their ability to do normal daily activities.

The school will make reasonable adjustments for pupils with disabilities, so that they are not at a substantial disadvantage compared with their peers.

## The four areas of need

The needs of pupils with SEND are grouped into four broad areas. Pupils can have needs that cut across more than one area, and their needs may change over time.

Interventions will be selected that are appropriate for the pupil's particular area(s) of need, at the relevant time. All students will have a 'One Page Profile' to set out short term targets based on their EHCP outcomes.

AREA OF NEED	
Communication and Interaction	Pupils with needs in this area have difficulty communicating with others. They may have difficulty understanding what is being said to them, have trouble expressing themselves, or do not understand or use the social rules of communication.
	Pupils who are on the autism spectrum often have needs that fall in this category.
Cognition and Learning	Pupils with learning difficulties usually learn at a slower pace than their peers.
	A wide range of needs are grouped in this area, including:
	<ul> <li>Specific learning difficulties, which impact one or more specific aspects of learning, such as: dyslexia, dyscalculia and dyspraxia</li> </ul>
	<ul><li>Moderate learning difficulties</li><li>Severe learning difficulties</li></ul>
	<ul> <li>Profound and multiple learning difficulties, which is where pupils are likely to have severe and complex learning difficulties as well as a physical disability or sensory impairment</li> </ul>
Social, Emotional and Mental Health	These needs may reflect a wide range of underlying difficulties or disorders. Pupils may have:
	<ul> <li>Mental health difficulties such as anxiety, depression or an eating disorder</li> </ul>
	<ul> <li>Attention deficit disorder, attention deficit hyperactive disorder or attachment disorder</li> </ul>
	Suffered adverse childhood experiences
	These needs can manifest in many ways, for example as challenging, disruptive or disturbing behaviour, or by the pupil becoming withdrawn or isolated.
Sensory and/or Physical	Pupils with these needs have a disability that hinders them from accessing the educational facilities generally provided.
	Pupils may have:
	<ul> <li>A sensory impairment such as vision impairment, hearing impairment or multi-sensory impairment</li> <li>A physical impairment</li> </ul>
	<ul> <li>Sensory processing disorder</li> <li>These pupils may need ongoing additional support and equipment to access all the opportunities available to their peers.</li> </ul>

# **Roles and responsibilities**

#### The SENCO

They will:

- Inform any Parents/Carers that their child may have SEN and then liaise with them about the pupil's needs and any provision made
- Work with the head teacher and SEN governor to determine the strategic development of the SEND policy and provision in the school
- Have day-to-day responsibility for the operation of this SEND policy and the coordination of specific provision made to support individual pupils with SEN, including those who have EHC plans
- Provide professional guidance to colleagues and liaise and work with staff, Parents/Carers, and other agencies to make sure that pupils with SEN receive appropriate support and high-quality teaching
- Advise on the approach to providing SEN support and differentiated teaching methods appropriate for individual pupils
- Advise on the deployment of the school's delegated budget and other resources to meet pupils' needs effectively
- Be a point of contact for external agencies, especially the local authority (LA) and its support services, and work with external agencies to ensure that appropriate provision is provided
- Liaise with potential next providers of education to make sure that the pupil and their parents are informed about options and that a smooth transition is planned
- When a pupil moves to a different school or institution: Make sure that all relevant
- information about a pupil's SEN and the provision for them are sent to the appropriate authority, school or institution in a timely manner
- Work with the head teacher and school governors to make sure the school meets its responsibilities under the Equality Act 2010 with regard to reasonable adjustments and access arrangements
- Make sure the school keeps its records of all pupils with SEND up to date and accurate
- With the head teacher, monitor to identify any staff who have specific training needs regarding SEN, and incorporate this into the school's plan for continuous professional development
- With the head teacher, regularly review and evaluate the breadth and impact of the SEND support the school offers or can access, and co-operate with the LA in reviewing the provision that is available locally and in developing the local offer
- Prepare and review information for inclusion in the school's SEN information report and any updates to this policy

• With the head teacher and teaching staff, identify any patterns in the school's identification of SEN, both within the school and in comparison with national data, and use these to reflect on and reinforce the quality of teaching

#### Governance

Governance is responsible for making sure the following duties are carried out, though the duties can be delegated to a committee or an individual:

- Co-operate with the LA in reviewing the provision that is available locally and developing the local offer
- Do all it can to make sure that every pupil with SEND gets the support they need
- Make sure that pupils with SEND engage in the activities of the school alongside pupils who don't have SEND
- Inform Parents/Carers when the school is making special educational provision for their child
- Make sure that the school has arrangements in place to support any pupils with medical conditions
- Provide access to a broad and balanced curriculum
- Have a clear approach to identifying and responding to SEND
- Record accurately and keep up to date the provision made for pupils with SEND
- Make sure that there is a qualified teacher designated as SENCO for the school and that the key responsibilities of the role are set out, and monitor the effectiveness of how these are carried out
- Determine their approach to using their resources to support the progress of pupils with SEND

## The Head Teacher

#### The head teacher will:

- Work with the SENCO and SEND link governor to determine the strategic development of the SEND policy and provision within the school
- Work with the SENCO and school governors to make sure the school meets its responsibilities under the Equality Act 2010 with regard to reasonable adjustments and access arrangements
- Have overall responsibility for, and awareness of, the provision for pupils with SEND, and their progress
- Have responsibility for monitoring the school's notional SEND budget and any additional funding allocated by the LA to support individual pupils
- Make sure that the SENCO has enough time to carry out their duties

- Advise the LA when a pupil needs an EHC needs assessment, or when an EHC plan needs an early review
- With the SENCO, monitor to identify any staff who have specific training needs regarding SEN, and incorporate this into the school's plan for continuous professional development
- With the SENCO, regularly review and evaluate the breadth and impact of the SEND support the school offers or can access, and co-operate with the LA in reviewing the provision that is available locally and in developing the local offer
- With the SENCO and teaching staff, identify any patterns in the school's identification of SEN, both within the school and in comparison with national data, and use these to reflect on and reinforce the quality of teaching

# **Class Teachers**

#### Each class teacher is responsible for:

- Planning and providing high-quality teaching that is adapted to students needs
- The progress and development of every pupil they teach
- Working closely with any teaching assistants or specialist staff to plan and assess the impact of support and interventions, and consider how they can be linked to classroom teaching
- Working with the SENCO to review each pupil's progress and development, and decide on any changes to provision
- Working alongside external professionals following advice and ensuring implementation of programmes including; Speech and Language; Educational Psychologist; Occupational Therapist; Visual Impairment support.
- Ensuring they follow this SEND policy and the SEN information report
- Communicating with parents regularly to:
  - Set clear outcomes and review progress towards them
  - Discuss the activities and support that will help achieve the set outcomes
  - $_{\odot}\,$  Identify the responsibilities of the parent, the pupil and the school
  - Listen to the parents' concerns and agree their aspirations for the pupil

## **Parents or Carers**

Parents/Carers should inform the school if they have any concerns about their child's progress or development.

Parents/Carers will always be given the opportunity to provide information and express their views about the pupil's SEND and the support provided. They will be invited to participate in discussions and decisions about this support. They will be:

• Invited to annual reviews to review the provision that is in place for their child

- Asked to provide information about the impact of SEN support outside school and any changes in the pupil's needs
- Given the opportunity to share their concerns and, with school staff, agree their aspirations for the pupil
- Given a report on the pupil's progress once a year with discussion at Parents/Carers evenings (three times a year)

The school will take into account the views of the Parents/Carers in any decisions made about the pupil.

# The Pupil

Pupils will always be given the opportunity to provide information and express their views about their SEND and the support provided. They will be invited to participate in discussions and decisions about this support. This might involve the pupil:

- Explaining what their strengths and difficulties are
- Contributing to setting targets or outcomes
- Attending review meetings
- Giving feedback on the effectiveness of interventions

The pupil's views will be taken into account in making decisions that affect them, whenever possible.

## **SEN information report**

The school publishes a SEN information report on its website, which sets out how this policy is implemented in the school.

The information report will be updated annually and as soon as possible after any changes to the information it contains.

## Evaluating the effectiveness of SEN provision

We evaluate the effectiveness of provision for pupils with SEN by:

- Tracking pupils' progress
- Monitoring and Evaluation: learning walks, observation and scrutiny
- Using pupil questionnaires/pupil voice
- Monitoring by the SENCO
- Holding annual reviews for pupils with EHC plans
- Getting feedback from the pupil and their parents
- Working with the LA and reviewing provision for the cohort of students

- Advice and support from external professionals and the team within the trust
- Termly QA visits from the Trust School Improvement Team
- Curriculum and staff skills audit

#### Expertise and training of staff

All staff will receive a minimum expectation training package to ensure that they have the skills necessary to support the needs of our school community.

Weekly staff development sessions provide an up to date CPD programme for staff.

Through performance management and in line with whole school improvement and changing needs, senior leaders will continuously monitor to identify any staff who have specific training needs and will incorporate this into the school's plan for continuous professional development.

Where individual students require specific support training will be provided to their most regular staff.

Staff are fully supported and encouraged to attend networks within the trust and wider local authority to share best practice and work collaboratively with colleagues for a city/trust wide approach.

#### Links with external professional agencies

The school recognises that it won't be able to meet all the needs of every pupil. Whenever necessary the school will work with external support services such as:

- Speech and language therapists
- Specialist teachers or support services
- Educational psychologists
- Occupational therapists, speech and language therapists or physiotherapists
- General practitioners or pediatricians
- School nurses
- Child and adolescent mental health services (CAMHS)
- Education welfare officers
- Social services

## Admission and accessibility arrangements

#### **Admission arrangements**

All students who attend Portland School have an Education, Health and Care plan. Pupils considered for placement will:

- Will have Social, Emotion and Mental Health as their primary area of need
- May have additional needs which may include;
  - Attachment disorder
  - Autism Spectrum Condition
  - Attention Deficit Hyperactivity Disorder
  - Moderate learning need
  - Physical Disabilities
  - Sensory Impairment (VI, HI, MSI)

#### Accessibility arrangements

The schools accessibility plan can be requested from our school office by contacting School Business Manager, Helen McDonald. Our accessibility plan covers how we:

- Increase the extent to which disabled pupils can participate in the curriculum
- Improve the physical environment to enable disabled pupils to take better advantage of the education, benefits, facilities and services you provide
- Improve the availability of accessible information to disabled pupils

## **Complaints about SEND provision**

Where parents have concerns about our school's SEND provision, they should first raise their concerns informally with the class teacher. We will try to resolve the complaint informally in the first instance. If this does not resolve their concerns, Parents/Carers are welcome to submit their complaint formally. Formal complaints about SEND provision in our school should be made to the SENCO in the first instance.

If the Parent/Carer is not satisfied with the school's response, they can escalate the complaint. In some circumstances, this right also applies to the pupil themselves.

#### Monitoring and evaluation arrangements

#### **Evaluating the effectiveness of the policy**

We are constantly looking for ways to improve our SEND policy. We will do this by evaluating whether or not we are meeting our objectives set out in section 1.

We will evaluate how effective our SEND provision is with regards to:

- All staff's awareness of pupils targets identified in their EHCP
- Pupils' progress and attainment in line with expectations of students with similar start points
- Whether pupils with SEND feel safe, valued and included in the school community
- Comments and feedback from pupils and their families

#### Monitoring the policy

This policy will be reviewed by the Head teacher and SENCO **annually**. It will also be updated when any new legislation, requirements or changes in procedure occur during the year.

It will be approved by Governance.
