Poor hygiene practice	Staff Pupils Others	Ill health	<ul style="list-style-type: none"> ● You should continue to ensure that children clean their hands regularly, this can be done with soap and water or hand sanitiser ● Staff and visitors are encouraged to wash their hands with soap or alcohol-based sanitiser (that contains no less than 60% alcohol) and follow infection control procedures in accordance with the DfE and PHE's guidance. ● Sufficient amounts of soap (or hand sanitiser where applicable), clean water and paper towels are supplied in all toilets and kitchen areas. ● Pupils are supervised by staff when washing their hands to ensure it is done correctly, where necessary. ● Pupils are discouraged from sharing cutlery, cups or food. Spread of infection	Staff Pupils Others	Lack of infection control	<ul style="list-style-type: none"> • Spillages of bodily fluids, e.g. respiratory and nasal discharges, are cleaned up immediately in line with guidance, using PPE at all times. • Parents are informed not to bring their children to school or on the school premises if they show signs of being unwell and believe they have been exposed to coronavirus. • Staff and pupils do not return to school before the minimum recommended exclusion period (or the 'self-isolation' period) has passed, in line with national guidance. • Pupils who are unwell are not taken on school trips or permitted to enter public areas used for teaching, e.g. swimming pools. • Parents notify the school if their child has an impaired immune system or a medical condition that means they are vulnerable to infections. • The school in liaison with individuals' medical professionals where necessary, reviews the needs of pupils who are vulnerable to infections. • Any additional provisions for pupils who are vulnerable to infections are put in place by the 	MED		✓

			<p>area where they will not come into contact with others and are supervised at all times.</p> <ul style="list-style-type: none">● For pupils the relevant member of staff calls for emergency assistance immediately if pupils' symptoms worsen.● The parents of unwell pupils are informed as soon as possible of the situation by a relevant member of staff.● Where contact with a pupil's parents cannot be made, appropriate procedures are followed in accordance with those outlined in governmental guidance.● Unwell pupils who are waiting to go home are kept in an area where they can be at least two metres away from others.● Areas used by unwell staff and pupils who need to go home are appropriately cleaned once vacated, using a disinfectant and care to be taken when cleaning all hard surfaces.● If unwell pupils and staff are waiting to go home, they are instructed to use different toilets to the rest of the school to minimise the spread of infection.● Any pupils who display signs of infection are taken home immediately, or as soon as practicable, by their parents – the parents are advised to contact NHS 111 immediately or call 999 if the pupil becomes seriously ill or their life is at risk.● Any members of staff who display signs of infection are sent home immediately and are advised to contact NHS 111 immediately or call 999 if they become seriously ill or their life is at risk.

Poor management of infectious diseases	Staff Pupils Others	Lack of infection control	<ul style="list-style-type: none"> ● Staff are instructed to monitor themselves and others and look out for similar symptoms if a pupil or staff member has been sent home with suspected coronavirus. ● Staff are vigilant and report concerns about their own, a colleague's or a pupil's symptoms to the Headteacher or SLT as soon as possible. ● The school is consistent in its approach to the management of suspected and confirmed cases of coronavirus. ● The school is informed by pupils' parents when pupils return to school after having coronavirus – the school informs the relevant staff.
