Question Types

6 questions on the paper covering all areas of the specification There is a variety of formats within each question.

These may include: Single word answers to parts of a diagrams Completion of charts Visual stimulus to answer a set of questions Short answers requiring a single sentence or phrase Slightly longer answers responding to command words Describe or Explain. Extended response question uses ' Discuss' or 'Evaluate' – max 8

Exam Technique - General Tips

Highlight key words & plan the response Use the key command words to understand the level of detail required Go back and re-read the questions and your answers Think about scattergun & contradictory responses Focus on any scenarios in the stem of the question Assume the examiner knows nothing!



One or two mark responses

Lower level key words: state/give/identify/name looking for a list of one or two word answers

Number of items required always clearly stated

Be careful of contradictory responses





Contradictory – Short answer questions

Usually one mark questions where candidates are required to provide one short answer only

If the candidate attempts three then mark no awarded

When completing a table where a number or letter is required in each box – only ONE attempt should be made. Examiners will think they are 'hedging their

bets'!



"When a candidate provides contradictory responses, then no mark should be given, even if one of the answers is correct" 'Loud speaking, quiet speaking?'!

Three to four mark responses

Mid range mark key words: Describe -

requiring candidate to provide the key features or a detailed

account





Factual

No reasoning e.g.: Describe two ways that the doctor could support Thomaz's right to consultation

Be careful of repeating facts



Explain the mid band response questions 4 to 6 marks

Often thought of as: Provide a description and a reason 'The how and why' e.g.:-

Explain HOW Sunita could challenge the discriminatory behaviour she has experienced.



Key words

Mid to higher mark key words **Explain – requiring candidate to formulate** an answer to include a step-by-step type of procedure, it can also mean to make plain and comprehensive or to offer justification. The meaning will depend upon the structure and subsequent wording of the question (i.e.) "Explain why, explain how or explain the...." will all elicit different answers
