Year 5 - We are continuing to work on multiplication and division and have been building up to multiplying 4 by 2-digit numbers

Year 6 - Following on from our recent assessments we have made some adjustments to teaching sets before we move on to look at Fractions.

Year 7 - We are completing our block on multiplication and division where we will be looking at formal methods as well as how to use them to calculate the area of triangles and trapezia.

Year 8 - We are moving into our 4th unit which is based around algebra and algebraic notation.

What Schools Need to Know about

The Online Safety Act was passed into UK law in October 2023, with the aim of establishing major new layers of protection for children when they re online. The government has pledged "a zero-tolerance approach to protecting children from online harm? — and the act certainly includes more powerful legislation which should help to safeguard young people in the digital world. Our guide summarises the key points for schools

There are some issues on which the legislation remains less clear for now: whether it's possible for Otcom to scan encrypted private messages (such as on WhatsApp) has yet to be resolved, for instance making this on area where, for the moment, young peop have less legal protection.

Schools should also esplain to parents and carers the new possibilities that the Online Safety Act affords them in terms of protecting their children. Many parents may have previously felt that there was little they could do about changing anline platforms' content; they now have a far greater level of support when complaining about a company or the behaviour of an individual.

What this means for you

The act has some specific implications for schools: it's essential that leaders understand the new legislation's scope and limitations. The act is certainly a positive step, but as artificial intelligence and other advances in tech continue to produce new challenges, schools will still need to remain extremely vigitant

REMEMBER THE ESSENTIALS

Remain mindful of your organisation's own online activities: the legal duty for schools to mointain appropriate software monitoring and filtering, for example, will not change.

KNOW WHERE TO GET HELP

ak out for the Code of Conduct that Ofcorn is creating response to the Online Safety Act. Note that the new egislation doesn't mean an instant change: many of its iements will only come into force of the end of 2023. An bicom consultation on 'protecting people from illegal arms online' will be running until February 2024.


