Late Collection Policy

Purpose

We know that families lead busy lives, and sometimes things don't go to plan. This policy is here to help us manage those moments with care and clarity, ensuring children remain safe and supported while also respecting the time and wellbeing of our staff.

Policy Statement

We recognise that unforeseen delays can occasionally occur, and we aim to support families with understanding and flexibility. Our primary concern is the safety and wellbeing of the children in our care. To ensure we can continue providing high-quality care and maintain appropriate staffing levels, a late collection fee is applied when children are picked up after their scheduled time. We encourage open communication and will always consider individual circumstances with empathy and discretion.

Procedure

1. Grace Period

• We offer a 5-minute grace period after the scheduled collection time, recognising that small delays are sometimes unavoidable.

2. Late Fee Charges

- First 15 minutes late: £14 flat fee.
- **Beyond 15 minutes:** £14 per 15 minutes thereafter.
- If a meal is provided due to lateness: An additional £2.90 charge will apply.

3. Communication

- If you're running late, please let us know as soon as possible.
- If we haven't heard from you, we'll try to contact you and your emergency contacts to ensure everything is okay.

4. Safeguarding Procedure

• If a child remains uncollected 30 minutes after closing and we're unable to reach anyone, we may need to contact the local authority or police to ensure the child's safety.

5. Recording and Invoicing

 All late collections are noted in our records and any fees will be added to your monthly invoice.

6. Ongoing Support

• If lateness becomes a regular issue, we'll reach out to discuss how we can support you and explore solutions together.

Exceptional Circumstances

We know that emergencies and unexpected events happen. If you've experienced something out of your control, please speak to us - late fees may be waived at the discretion of the Headteacher.
