Training</p> <ul style="list-style-type: none"> • All staff have completed online training in the following areas: Child Protection Refresher, Child Exploitation and Online Safety. All staff have completed the training booklets, which accompany each session and these are filed in personnel files. • Further training is planned throughout the year, this will include: Keeping Children safe in Education and Annexe A of the guidance, Children Missing Education and Female Genital Mutilation. • Kath Brown is to attend the Home Office PREVENT training and then lead training for the staff. • All designated staff have attended annual refresher training. Individual training has covered Safer Recruitment, Supervision Skills, Looked after Children and Child Protection and links to Attendance • Child Protection training has been booked for all governors and Ruth Oseme will attend specific training for the Safeguarding Governors. • All staff receive relevant updates including PREVENT and One Minute guides and shared with staff and available on staffshare. <p>2. Supervision</p> <ul style="list-style-type: none"> • Collette Lawson DSL receives half-termly supervision from Amanda Hargreaves TSL and following recent training the CP is developing individual supervision for the rest of the team. • Group supervision takes place weekly when the Safeguarding team meet. • The team has recently begun file scrutiny, where an individual's CPOMs record is reviewed to ensure all incidents and procedures have been followed up and completed. <p>COVID</p> <ul style="list-style-type: none"> • All national and local authority updates regarding safeguarding throughout the pandemic, have been adopted by the school. • Pupils have completed the My School Survey around their experiences and concerns throughout the pandemic. An analysis of this data is being completed

	<p>and any areas of concern amongst respondents acting upon</p> <p>General safeguarding</p> <ul style="list-style-type: none"> • Single central register- Ruth to look at register during a link meeting • Early Help plans; school is a linked agency with 3 plans, but not the lead. Billy Waters and Collette Lawson, have received the local authority training and are now able to open and lead plans. Many cases that close to social care now become subject to an Early Help Plan. They can also be opened for families where school feels that a multi agency plan is necessary for families, which don't meet the threshold for social care but do require a high level of support.
