



## St Bartholomew's C of E Primary

### Relationships and Sex Education (RSE) Consultation Report    Spring 2021

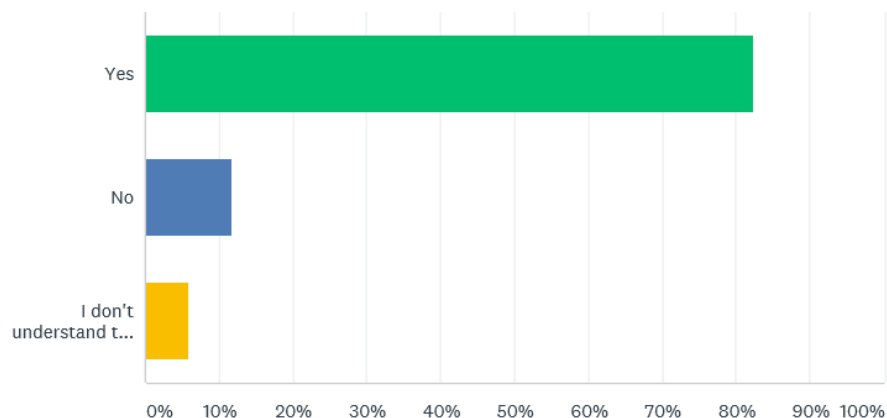
In line with government guidelines and the new RSE curriculum St Bartholomew's C of E Primary School consulted on their RSE Policy with parents and stakeholders from the 22nd February 2021 to the 31<sup>st</sup> March 2021. Prior to the consultation a working party group consisting of staff and governors discussed the curriculum, draft policy document and other supporting documents . (letters, powerpoint presentation, survey and information leaflet) that would provide information for parents and stakeholders. Parents were informed of the consultation by newsletter and the information and questionnaire was posted on the school website. Parents had the opportunity to comment and offer suggestions for the new policy.

At the end of the consultation period 17 stakeholders had responded to the questionnaire (two of the 17 were staff members testing the survey) With a school population of over 500 pupils this was not a significant response. The vast majority of the responses were very positive with only 5.88% stating that they would not be happy for their child to take part in RSE lessons. This was one stakeholder. Five other parents expressed that they would consider withdrawing their child from lessons. It was explained that sex education and conception was not covered until year 6. This has now been made clear in the policy

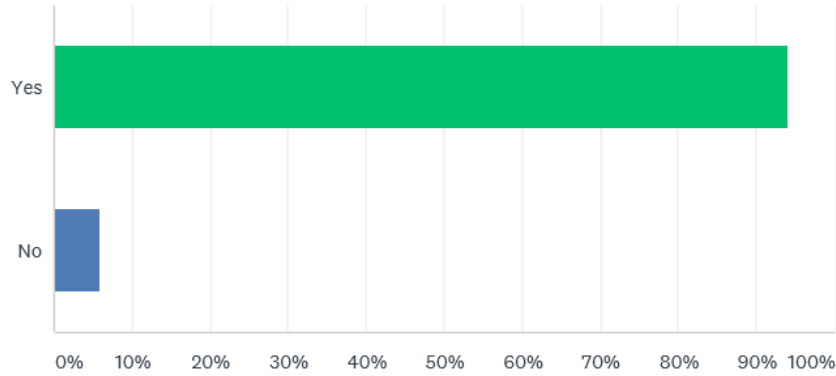

# Are you happy with the contents of the draft RSE Policy?

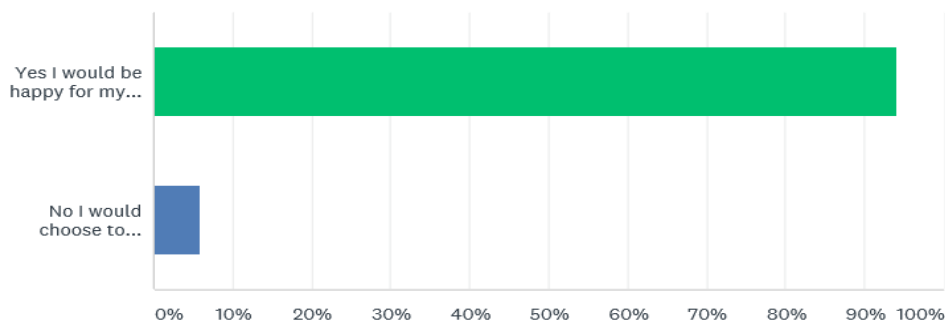

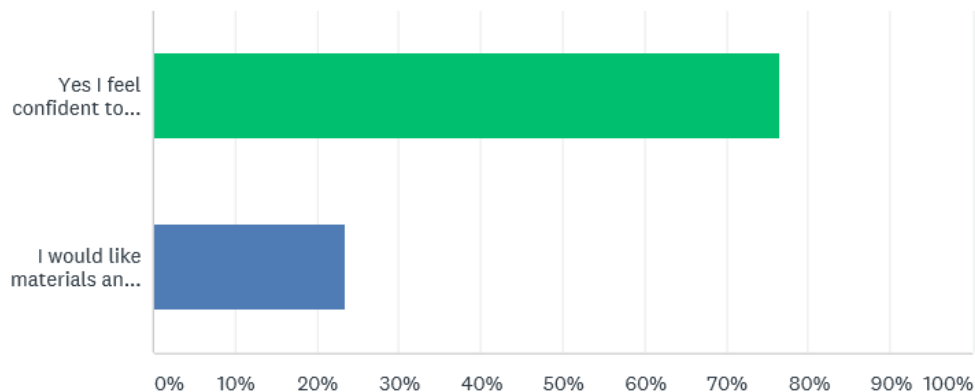

4. **Offer information to parents to assist with discussions at home about RSE.**
5. **Review the policy in line with recommended dates.**
