Accessibility Plan and Policy 2022-2024

This Accessibility Plan and Policy are drawn up in compliance with current legislation and requirements as specified in Schedule 10, relating to Disability, of the Equality Act 2010. A person is regarded as having a disability under the Act where they have a physical or mental impairment that has a substantial and long-term adverse effect on their ability to carry out normal day-to-day activities.

Lilycroft and St Edmund's Nursery Schools are committed to working together to provide an inspirational and exciting learning environment where all children can develop an enthusiasm for life-long learning. We believe that children should feel happy, safe and valued so that they gain a respectful, caring attitude towards each other and the environment both locally and globally.

The Governing Body are accountable for ensuring the implementation, review and reporting on progress of the Accessibility Plan over a prescribed period.

- 1. Lilycroft and St Edmund's Nursery Schools are committed to providing an accessible environment, which values and includes all children, staff, parents and visitors regardless of their education, physical, sensory, social, spiritual, emotional and cultural needs. We are committed to challenging negative attitudes about disability and accessibility and to developing a culture of awareness, tolerance and inclusion.
- 2. Lilycroft and St Edmund's Nursery Schools plan, over time, to ensure the accessibility of provision for all children, staff and visitors to the school.
- 3. The Accessibility Plan will cover a two-year period and will be updated annually.
- 4. The Accessibility Plan will contain relevant actions to:
- Improve access to the **physical environment** of the schools, adding specialist facilities as necessary. This covers reasonable adjustments to the physical environment of the schools and physical aids to access education.
- Increase access to the **curriculum** for children with a disability, expanding and making reasonable adjustments to the curriculum as necessary to ensure that children with a disability are as, equally, prepared for life as all other

children. This covers teaching and learning and the wider curriculum of the schools such as participation in additional activities like football sessions, Forest School or school trips. It also covers the provision of specialist aids and equipment, which may assist these children in accessing the curriculum.

- Improve and make reasonable adjustments to the delivery of **written information** to children, staff, families and visitors with disabilities. Examples might include letters home, information about the schools and school events. The information should be made available in various preferred formats within a reasonable time frame.
- 5. The Action Plan for physical accessibility relates to the Accessibility Audits of the schools, which were undertaken by the Department of Children's Sensory Service in regards to access for children with Visual Impairment and by the Physical and Medical Team in regards to accessibility of the physical environment for our children with disabilities.

It may not be feasible to undertake some of the works during the life of this Accessibility Plan and therefore some items will roll forward into subsequent plans.
