1. Aims

This policy statement sets out the school's arrangements for managing the access of providers to pupils at the school for the purpose of giving them information about the provider's education or training offer. This complies with the school's legal obligations under Section 42B of the Education Act 1997.

- To find out about technical education qualifications and apprenticeship opportunities, as part of a careers programme, which provides information on the full range of education and training options available at each transition point
- . To hear from a range of local providers about the opportunities they offer regarding technical education and apprenticeships through options evenings, assemblies, careers workshops and taster events.
- To understand how to make applications for technical courses and apprenticeships.

The school calendar varies from year to year, so providers need to contact the appropriate staff member named above to identify the most suitable opportunity. These events are usually calendared well in advance, so it is essential that providers contact us early in the academic year to be involved in our planning.

Access to pupils will be granted on the understanding that the information and guidance offered by providers is related to post 16 courses, technical courses and apprenticeship opportunities only. Safeguarding requirements must also be met. The school policy on safeguarding sets out the school's approach to allowing providers into school as visitors to talk to our pupils.

5. Premises and Facilities

Access to appropriate rooms and facilities will be discussed and agreed in advance of the visit. We will make available presentation facilities and other specialist equipment to support provider presentations. Providers are welcome to hand us relevant brochures and leave a copy of their prospectus. These will be made available to pupils in the school library, in the careers room, in tutor rooms and on the careers display boards.

6. Monitoring and review

This policy will be reviewed annually by Mrs E Shahsvar, lead for CEIAG.
