	Chair of Governors reported the appraisal meeting has taken place and awaiting report from the meeting.

	The Headteacher said following on from the academisation meeting the following paperwork has been received for Governor reference and information: - Example set of minutes of meeting to show how converting to an academy must be minuted - Due diligence stage one request for information document - Application process paperwork document - Example letters to inform parents. - Recovery Plan submission	
	The Headteacher said each school within an academy should be financially secure, the Diocese are aware that some schools are not secure. We will need to have a 3-year budget in terms of recovery, the Diocese will help with this.	
	Governor said its very important that the Governing body must be persuaded to the merits of academisation for our individual school. There is an element of direction of travel and a big element of if everyone else does it then we will.

The Headteacher informed Governors the Governing Body need to decide if they want to proceed with academisation, the first step is to complete due diligence.

Governors discussed academisation.

Governor suggested speaking to other schools that have already academised to find out their experience. Headteacher said St. George's school academised and it was a lot of work, the school hasn't changed much but there are small changes overtime.

Governor asked if being part of an academy would benefit staff? The Headteacher said his understanding is it would be like ELP (Ealing Learning Partnership). There would be an Executive Head across the whole academy and a Chief Finance Office and Head of Human Resources

The Headteacher said the Governing Body can say no to academisation and do nothing or start the due diligence. Starting due diligence does not commit us to academisation, we might find we aren't financially viable in 3 years and then academisation is not viable.

Governor asked in what timescale, if at all, will the Governing Body be asked to sign a resolution and on what basis do the Governing Body take the decision? The Headteacher said he will find out the process for moving forward with academisation and report back.

Governor said its important the Governing Body is presented with the pros and cons from the Diocese.

Governor asked at what stage are parents involved. The Headteacher said parents would be informed after the due diligence.

The Headteacher asked Governors to start thinking about the due diligence for academisation.

The Headteacher said there will be no forced academisation but a concern is that we are left out.

Governor said there are lots of questions to be asked and the reason behind academisation is flawed.

Governor said a concern would be what is coming from above. The Headteacher and Senior Leadership Team are the driving force at school, what will happen if there is an Executive Headteacher.

Governors requested the Headteacher to provide pros and cons for academisation at the next meeting. The Headteacher agreed.

Headteacher agreed to find out the exact process for academisation report back in September.

Governors agreed.

3e	Reducing PAN (Pupil Admission Number)	
	The Headteacher reported following a meeting with Ealing from 2024 there begins to be a drop off in pupil numbers.	
	The Headteacher informed Governors school has struggled with pupil numbers for a while. The current Reception year is 51% Catholic and the new reception intake is similar. Catholicity will begin to reduce.	
	For September 2024, reducing PAN is an 18 month process and we would have to go out to consultation. Ealing will support reducing PAN.	
	Chair of Governors said looking at the numbers it is unlikely there is going to be a surge in birth rate.	
	Headteacher said there could possibly be an increase in the birth rate in 2027, a bulge year could be added if necessary.	
	The Headteacher asked if Governors want to wait and see what happens with numbers or start to talk to Ealing now with a view to reducing PAN.	
	Governors agreed for the Headteacher to proceed with Ealing on reducing PAN.
