

| | The Headteacher said the return to school has been successful. The headteacher informed Governors: | |

- Staff and children are temperature checked on arrival
- Staggered start times in place
- Year groups are in bubbles
- Pick up and exit procedures have been changed as safety issues arose from parents and children standing in the road. Since the change pick-up has settled down.
- Children and staff have been fantastic at adopting the new routines.

The headteacher said he is expecting a year group to be quarantined at some point due to children and parents mixing outside the school gates.

A Governor asked what percentage of children were back at school. The Headteacher said the numbers had varied but currently about 92% are in school.

The Headteacher informed Governors about the number of pupil vacancies in school:

The Headteacher said 37 places are available and St. Joseph's is in a better position than some other schools in Ealing. Children have left due to parents losing jobs, families moving back to Poland or families moving out of London. The Headteacher said we need to ensure parents want to continue sending their children to St. Joseph's.

A Governor asked if due to Covid-19, has it been difficult to get parents into view the school? The Headteacher said parent tours have taken place on Friday evenings in groups of 10.

A Governor asked if a PowerPoint presentation is available for parents to view on the school website. The Headteacher said he prefers to have parent tours on Friday evening but will ensure the PowerPoint is available on the school website.

The Headteacher informed Governors the number of children with EHCPs, social workers and children on the SEN register.

The Headteacher said the SENCO was working with teachers to ensure children were getting the help they need. The SENCO is currently busy with referrals for children in Nursery and Reception.
