Purpose

1. **Dogs teach children responsibility.** Having to remember to feed, provide water and show support for a dog can give children a sense of importance and satisfaction that they can't get from school or other chores. The relationship that develops can be life-changing for a child and a great support system as they themselves continue to grow and develop.
2. **Dogs teach children patience.** Dogs do not always do as they are told first time!
3. **Dogs teach children compassion.** Just like humans, dogs feel emotion and pain. They are prone to injuries and the infirmities of age during their relatively short lives.
4. **Dogs teach children about socialisation.** Like most of us, dogs are social animals who enjoy and need attention and affection. By learning how to interact with a dog, children can learn how to better socialise with other children. If they can learn the social cues of a dog, then interacting with humans who can talk will be a walk in the park (pun intended).
5. **Improved attendance.** In many schools that have introduced a school dog attendance has improved.
6. **Reading success.** By reading to a dog many reluctant and nervous readers significantly improve their word reading and comprehension.
7. **Dogs are fun.** Last, but certainly not least, dogs are a lot of fun. They greet you with a wagging tail every day and can cheer you up even on your worst day.

Introduction

The St Luke's Academy Dog '**Willow**' lives with our Assistant Principal, Mr Green, and his family as their pet. Willow was named after the famous book ' The Wind in the Willows' and will become St Luke's reading/therapy dog.

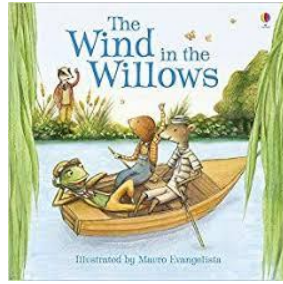
Willow is a very caring and well behaved dog who has the right temperament to work well at St Luke's Academy.

Willow's mother is a black Labrador called Star and her father is a yellow Labrador called Dave.

Willow has insurance, this means she can come into school. Willow has regular visits to the vet for check-ups. Whilst she is there they administer worm and flea treatments as well as make adjustments to her diet to ensure she remains a healthy.

It is really important to remember to approach Willow in a calm manner, waiting for her to come to you, avoiding large/sudden movements and keeping our noise levels down.

You must wash your hands after coming into contact with Willow.

Parents have been contacted about the introduction of a school dog and asked to let the school know if they don't want their child to	Medium	Ensure that children and adults do not interact with the school dog without supervision. Willow will be under control of an authorised adult.

Running loose	If the school dog was to run loose she could hurt children/adults or damage property	The school dog will be contained in a safe place for some of the day (office). When out and about the school dog will be supervised by an adult, a lead when appropriate and be trained to follow instructions.	Low	Monitor that office is effective, And lead is working appropriately.
Negative interaction with children and adults	If the school dog is allowed to interact when not in the correct frame of mind children and staff could be scratched.	No interaction is allowed without authorisation. Interaction will be cancelled if the school dog shows signs of incorrect behaviour. Praise given to reinforce the correct behaviour.	Medium	Ensure the dog is approached in the correct manner.
Destruction of materials	Labradors can be chewy. If allowed Willow may chew and destroy some school materials and resources.	School dog to be supervised at all times when out of cage or office. She will have her own toys to play with and school resources removed if needed.	Low	Monitor that balls and toys used correctly.

Incorrect/ inconsistent interaction with dog	If a child/adult interact with the school dog in the incorrect or inconsistent way this will affect the school dogs training and have a negative impact on future interaction.	Agreed guidelines that must be followed at all times when interacting with the school dog. There cannot be any interaction with the school dog without authorisation.	Medium	If there are any inconsistencies in the approach with the school dog the adult/child will have the interaction stopped.
Use of rewards and treats	Children and adults could be harmd if the school dog is over excited when receiving a reward/treat. Adults and children must clean their hands after handling treats.	Treats will only be given to the school dog with authorisation. Hand to be washed afterwards.	Low	Reminders about washing hands. Treats to be locked away, only to be used when authorised.
Students and staff knowledge of interaction with a dog	If adults and children have limited knowledge of how to interact correctly this could result in harm to the school dog or themselves.	All students and staff to be introduced to the dog and shown what to do: - calm manner - waiting for her to come to you. - avoid large/sudden movements - keep noise levels low.	Medium	Monitor how well students and staff approach and interact with Willow.

Hygiene and Health

To ensure that students, staff and the school dog do not have an increased risk of illness as a result of the school dog being in school

Walking the dog on and off the lead	Children could be harmed during a walk offsite if they are not focussed. Children might be harmed if they do not interact correctly when the school dog is offsite	If the school dog is taken offsite the normal risk assessment procedure will take place. No children will take the lead unless authorised by an accompanying adult. No students to interact with the school dog when she is walking unless permission is given	Medium	Careful consideration needs to be given to the amount of time the school dog is allowed to walk around the school during breaks.
Visits to classroom	If the school dog visits a class and the children do not follow the correct procedure she may become excited or distressed.	The school dog will initially only do class visits with Mr T Green & Miss C Dougan. Students in the classroom will need to follow the agreed procedure or interaction will stop.	Medium	Careful consideration will be given to when the school dog can visit classrooms and be under the control of the class teacher or TA.
School events	If the school dog is overwhelmed she may become excited or distressed.	The school dog will only attend school events if they are appropriate and she will be under the control of a supervising adult.	Low	Monitor the dog's reaction to the school event. If the school events are too overwhelming
