### NEW THREAT IN HOUSE OF LORDS TO LEGALISE ASSISTED SUICIDE

Chair of the Voluntary Euthanasia Society, now euphemistically renamed "Dignity in Dying," Baroness Molly Meacher, introduced an Assisted Dying Bill into the House of Lords on 26th May last, days after the "Sunday Times" launched a campaign calling for the legalization of "assisted dying".

Alithea Williams of SPUC explained: "Baroness Meacher's bill has to be seen in light of a fresh assault on Westminster by the assisted suicide lobby. They failed to bring it in through the courts, so they are again turning their attention to Parliament. As a private members' bill starting in the Lords, Baroness Meacher's bill is very unlikely to make it into law, but it is all part of a concerted strategy to forward their agenda." The bill will be debated on October 22nd. Scotland is also facing the threat of legalised assisted suicide. The Scottish Parliament is expected to launch a consultation in the coming months, with the prospect of a bill in Holyrood in 2022.

Miss Williams went on: "The threat of assisted suicide, with all its horrific consequences, being legalized within our shores is very real. Whether it comes from Westminster or Holyrood, the effects will be felt throughout Britain. However, there is still time to fight it. "We need to be making the compassionate case that people are never burdens to be disposed of, and that everyone deserves love and care until the very end of life, regardless of age or frailty. We must speak out against the despair that leads people to think that their lives are worthless. We need to share the abundant evidence from countries which have legalized assisted suicide that it cannot be controlled and soon leads to involuntary euthanasia, euthanasia of children and psychiatric patients, and other vulnerable groups. "This bill marks the start of a new battle against the lives of the most vulnerable - we must fight back now."

175 medical professionals signed a letter addressed to the Scottish Health Secretary, Humza Yousaf. opposing Scotland's assisted suicide bill [05 July 2021] The letter was launched by Our Duty of Care (ODOC), is a response to the Assisted Dving Bill introduced into the Scottish Parliament...It states: "The shift from preserving life to taking life is enormous and should not be minimized. The prohibition of killing is present in almost all civilized societies due to the immeasurable worth of every human life. "Everyone has a right to life under Article 1 of The Human Rights Act 1998 such that no one should be deprived of that life intentionally."

The letter highlights the exploitation that vulnerable people may face if assisted dying is legalized: "Some patients may never consider assisted suicide unless it was suggested to them. The cruel irony of this path is that legislation introduced with the good intention of enhancing patient choice will diminish the choices of the most vulnerable. As health care professionals, we have a legal duty of care for the safety and wellbeing of our patients.....We the undersigned will not take patients' lives - even if they ask us to. But for the sake of us all, we ask that the law remains unchanged."

An SPUC spokesperson said: "Assisted suicide is not medicine but a turning away from life, towards death, in response to the challenge of care. "But the killing of a patient should never be the answer, as these 175 medical professionals rightly assert"
