## WHOLE SCHOOL POLICY FOR SAFEGUARDING & CHILD PROTECTION

## Chorley St Mary's Catholic Primary School and Nursery

The purpose of this safeguarding policy is to ensure every child who is a registered pupil at our school is safe and protected from harm. This means we will always work to:

- Protect children and young people at our school from maltreatment;
- Prevent impairment of our children's and young people's health or development;
- Ensure that children and young people at our school grow up in circumstances consistent with the provision of safe and effective care;
- Undertake that role so as to enable children at our school to have the best outcomes.

This policy will give clear direction to staff, volunteers, visitors and parents about expectations and our legal responsibility to safeguard and promote the welfare of all children at our school.

Our school fully recognises the contribution it can make to protect children from harm and to support and promote the welfare of all children who are registered pupils at our school.

This policy applies to all pupils, staff, parents, governors, volunteers and visitors.

This policy should be read in conjunction with the School's Safeguarding Portfolio.

Ethos	<ul> <li>Chorley St Mary's Catholic Primary School and Nursery recognises that high selfesteem, confidence, peer support and clear lines of communication with trusted adults helps all children, especially those at risk of, or suffering abuse. We therefore ensure that:         <ul> <li>ALL staff, volunteers and governors contribute to an ethos where children feel secure and safe</li> <li>ALL children have opportunities to communicate and know that they are listened to</li> <li>ALL children's wishes, feelings and views will be taken into account when decisions are being made about how to keep them safe</li> <li>ALL children know that they can communicate with any adult in school if they are worried or in difficulty</li> <li>ALL staff and volunteers will contribute to providing a curriculum which will equip children with the skills they need to stay safe and be able to communicate when they do not feel safe</li> </ul> </li> </ul>



Roles & Responsibilities	Chorley St Mary's Catholic Primary School and Nursery is committed to providing the relevant personnel with clear and explicit roles and responsibilities to ensure accountability when safeguarding children. We therefore ensure that:
	<ul> <li>All adults, including volunteers, working in or on behalf of the school will:</li> <li>Demonstrate an understanding that safeguarding is everyone's responsibility</li> <li>Maintain and demonstrate a mind set of "it could happen here"</li> <li>Do all they can within the capacity of their role, to keep ensure that children are protected from harm</li> <li>Do all they can within the capacity of their role, to ensure that children grow up in circumstances consistent with safe and effective care</li> <li>Do all they can within the capacity of their role, to ensure that children have the best outcomes</li> <li>Report cases of suspected abuse to the DSL. This will be done as soon as possible using the school's agreed format</li> <li>Report lower level concerns to the DSL using the school's agreed format</li> <li>Monitor all pupils, particularly those that are deemed vulnerable</li> <li>Report any concerns regarding adults conduct to the DSL or Headteacher</li> <li>All staff, if they have concerns, these should be acted on immediately and should always speak to the DSL or Deputy, early information sharing being vital in keeping children safe. In exceptional circumstances staff should consider speaking to a member of SLT or Children's Social Care to discuss safeguarding concerns if the DSL is not immediately available.</li> <li>All staff should be aware of the process for making referrals to children's social care and for statutory assessments under the Children Act 1989, especially section 17 (children in need) and section 47 (a child suffering, or likely to suffer, significant harm) that may follow a referral, along with the role they might be expected to play in such assessments</li> </ul>

	<ul> <li>ALL staff and volunteers understand the importance of teaching children how to keep themselves safe from all types of abuse</li> </ul>		
	<ul> <li>ALL staff and volunteers seek out opportunities that are relevant to their role, to teach children the skills to keep themselves safe</li> </ul>		
	<ul> <li>ALL staff and volunteers make and maintain positive and supportive relationships with children which enable children to feel safe and valued</li> </ul>		
	<ul> <li>safeguarding has a high status throughout school by being on the agenda at staff meetings/briefings, information being readily available on notice boards, regular updates</li> </ul>		
	<ul> <li>ALL staff feel confident in approaching DSLs to raise concerns</li> </ul>		
	ALL staff and volunteers have an understanding of the four categories of abuse; NEGLECT, EMOTIONAL ABUSE, SEXUAL ABUSE, PHYSICAL ABUSE.		
	• We will use Lancashire's Neglect Strategy 2019 and accompanying toolkit to identify and assess children whose developmental needs are being insufficiently met at an early stage, placing them at risk of achieving poor educational, emotional and social outcomes.

	• DSLs keep up to date with emerging and specific safeguarding issues and update training and the School's Safeguarding Portfolio accordingly		
	<ul> <li>DSLs update staff and volunteers knowledge and understanding of such issues in order for them to be able to identify children who are at risk of such specific safeguarding issues</li> </ul>		
	<ul> <li>ALL staff and volunteers will maintain and demonstrate an attitude of "it can happen here"</li> </ul>		
	ALL staff and volunteers are child-centred in their practice and act in the best interests of the child at all times		
	<ul> <li>ALL staff recognise and understand that behaviour can be a child's way of communicating distress and changes to behaviour may be an indicator of abuse</li> </ul>		
	<ul> <li>ALL staff and volunteers have the skills to respond appropriately and sensitively to disclosures or allegations of abuse</li> </ul>		
	• ALL staff and volunteers report cases of suspected abuse to the DSL. This will be done as soon as possible using the school's agreed format		
	<ul> <li>where a child is at risk of immediate harm, ALL staff understand that they must refer to the Police or Children's Social Care</li> </ul>

Any child may benefit from early help, but all school and nursery staff should be particularly alert to the potential need for early help for a child who: <ul> <li>is disabled and has specific additional needs;</li> <li>has special educational needs (whether or not they have a statutory education, health and care plan);</li> <li>is a young carer;</li> <li>is showing signs of being drawn in to anti-social or criminal behaviour, including gang involvement and association with organised crime groups;</li> <li>is frequently missing/goes missing from care or from home;</li> <li>is a risk of modern slavery, trafficking or exploitation;</li> <li>is in a family circumstance presenting challenges for the child, such as substance abuse, adult mental health problems or domestic abuse;</li> <li>has returned home to their family from care;</li> <li>is at risk of being radicalised or exploited;</li> </ul> </li> </ul>			
	<ul> <li>is a privately fostered child.</li> </ul>			
	<ul> <li>We therefore ensure that:</li> <li>ALL staff and volunteers can identify the risk factors that indicate a family or pupil may benefit from Early Help</li> </ul>			
	<ul> <li>ALL staff and volunteers will use the school's agreed format for letting the DSL know about Early Help requirements</li> </ul>			
	• DSLs will undertake a CAF assessment, when appropriate, to identify what Early

Specific Safeguarding	Chorley St Mary's Catholic Primary School and Nursery is committed to keeping our children safe from specific forms of abuse.			
	We will formulate risk management plans where required using the guidance and template below.			
	We will ensure that:			
	ALL staff and volunteers understand that there are specific and emerging ways in which children can be abused, such as:			
	<b><u>Radicalisation</u></b> refers to the process by which a person comes to support terrorism and forms of extremism, there is no single way of identifying an individual who is likely to be susceptible to an extremist ideology.			
	• ALL staff and volunteers will have 'due regard to the need to prevent people from being drawn into terrorism', known as the 'Prevent Duty'			



<b><u>Female Genital Mutilation (FGM)</u></b> is encompassed within the term Honour Based Violence
<ul> <li>ALL staff and volunteers are aware of the "one chance rule" and will report all cases of suspected Honour Based Violence to the DSL immediately</li> <li>FGM is illegal in the UK and a form of child abuse with long-lasting harmful consequences</li> <li>ALL staff need to be alert to the possibility of when a female pupil may be at risk of FGM or when it may have been conducted on them</li> <li>Whilst all staff should speak to the designated safeguarding lead (or deputy) with regard to any concerns about female genital mutilation (FGM), there is a specific legal duty on teachers. If a teacher, in the course of their work in the profession, discovers that an act of FGM appears to have been carried out on a girl under the age of 18, the teacher must report this to the police.</li> </ul>
<b>Modern Slavery</b> The Modern Slavery Act 2015 places a new statutory duty on public authorities, including schools, to notify the National Crime Agency (NCA) (section 52 of the Act) on observing signs or receiving intelligence relating to modern slavery. The public authority (including schools) bears this obligation where it has 'reasonable grounds to believe that a person may be a victim of slavery or human trafficking'.
• Staff must be aware of the above and contact the DSL should they suspect or receive information that either parents or their children may be victims of modern slavery. The DSL should then contact the NCA
<u>Peer on Peer Abuse</u> occurs when a young person is exploited, bullied and / or harmed by their peers who are the same or similar age; everyone directly involved in peer on peer abuse is under the age of 18. Please see <u>Peer on Peer abuse Pan Lancashire procedures</u>
This is most likely to include but may not be limited to: bullying (including cyberbullying); physical abuse such as hitting, kicking, shaking, biting, hair pulling, or otherwise causing physical harm; sexual violence and sexual harassment; sexting (also known as youth produced sexual imagery); upskirting; and initiation/hazing type violence and rituals.
<ul> <li>ALL staff and volunteers understand that children can abuse other children</li> <li>ALL staff and volunteers will inform the DSL of suspected peer abuse and record in line with schools recording policy</li> </ul>
<ul> <li>Peer on peer abuse will be taken as seriously as any other form of abuse</li> <li>All staff understand that abuse is abuse and should never be tolerated or passed off as "banter", "just having a laugh" or "part of growing up</li> <li>All staff will understand that pupils with SEND are more prone to peer group isolation and school will have extra pastoral support to address this.</li> <li>Physical abuse between peers will be managed under the school's <u>Behaviour</u> Policy</li> </ul>
<ul> <li>Emotional abuse between peers will be managed under the school's <u>Anti-Bullying Policy</u></li> <li>Harmful sexual behaviour will be identified and managed using the <u>Brook Traffic</u></li> </ul>
Light Tool and with support and guidance from LCC Schools Safeguarding Officer
<ul> <li>Sexting will be managed on a case by case basis using national and local guidance and advice from LCC Schools Safeguarding Officer – Link to Government Sexting Guidance</li> <li>Sexting will be managed on a case by case basis using national and local</li> </ul>

	<ul> <li>The DSL will consider:</li> <li>the wishes of the victim in terms of how they want to proceed</li> <li>the nature of the alleged incident</li> <li>the ages of the children involved</li> <li>the development stages of the children involved</li> <li>any power imbalance between the children</li> <li>is the incident a one-off or a sustained pattern of abuse</li> <li>are there ongoing risks to the victim, other children, school or college staff</li> <li>contextual safeguarding issues</li> </ul>
	<ul> <li>Following a report of sexual violence, the designated safeguarding lead (or deputy) will make an immediate risk and needs assessment, considering:         <ul> <li>the victim</li> <li>the alleged perpetrator</li> <li>all other children (and if appropriate adult students and staff).</li> <li>Risk assessments will be recorded and kept under review as a minimum termly.</li> </ul> </li> </ul>
