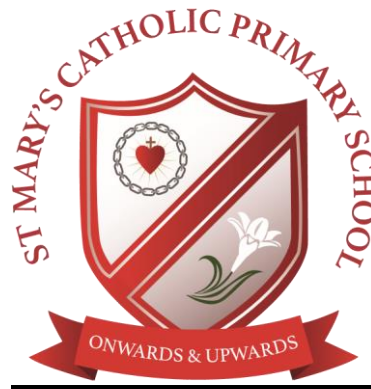

The Nature of Collective Worship

We believe that Christian worship in a Catholic school is concerned with giving glory, honour, praise and thanks to God. It is our loving response, in word and action, to God's invitation to enter into relationship, made possible through the work of Jesus Christ and the witness of the Holy Spirit.

Legal Requirements

We acknowledge the legal requirement that there must be a daily act of worship for all pupils. We understand that simply holding an assembly that includes a prayer, said either by the teacher or everyone present, does not fulfil this requirement. We also acknowledge that collective worship and assembly are distinct activities. They may sometimes form part of the same gathering, but the difference between the two will always be made clear.

The act of worship is not designated curriculum time under regulations and will not be subsumed under any part of the curriculum, including religious education.

In this school, responsibility for making sure that statutory requirements are met concerning Collective Worship rests with the Governing Body after consultation with the headteacher.

The Place of Collective Worship in the Life of our School

We endorse the belief that Collective Worship takes into account the religious and educational needs of all who share in it:

- Those who form part of the worshipping community in church
- Those for whom school may be their first and only experience of church
- Those from other Christian traditions - or none
- Those from other faith backgrounds.

It will be an educational activity or experience to which all can contribute and from which all can gain.

Worship in this school is more than just a legal requirement. It is an integral part of school life and central to the Catholic tradition.

The Aims of Collective Worship

We believe that Collective Worship in our school aims to provide opportunity for all pupils and staff:

- To contemplate something of the mystery of God
- To reflect on spiritual and moral issues
- To explore their own beliefs
- To respond to and celebrate life
- To experience a sense of belonging and develop community spirit
- To develop a common ethos and shared values
- To enrich religious experience
- To grow in liturgical understanding and development
- To reinforce prayers which are part of the Catholic tradition
- To reinforce positive attitudes
- To participate fully
- To take time out 'to wonder at', 'to come to terms with' and 'to give worth to.'

Principles

All Acts of Worship in this school will:

- Give glory and honour to God
- Be a quality activity, fundamental to the life of the school and its Catholic character
- Give children positive liturgical experiences, appropriate to their age, aptitude and family backgrounds in order to prepare them for the liturgical life of the Church. In order to do this, celebrations will:
 - be kept small wherever possible or appropriate to help to personalise the experience;
 - be simple, including a range of experiences offered in a variety of groupings and in a variety of settings.
 - regularly involve the children in the planning and delivery of the liturgy.

Worship and Liturgy will take the form of:

- Prayers at the beginning and end of each day, and before meals.
- Longer quiet times of prayer and reflection
- Appropriate assemblies
- Liturgies and Masses

The Planning, Content and Delivery of Collective Worship

Collective Worship is planned:

- following a structure with reference to the Church's seasons, 'The Way, The Truth and The Life', significant dates and the curriculum. Scripture will be the focus in most acts of worship
- using the Wednesday Word resources
- involving consultation with appropriate parties and reference to school aims and policies
- with flexibility to respond to changing situations within the school and the wider community
- to develop in pupils skills that enable them to prepare, organise and lead worship rather than always participating or contributing in a token way.

Recording

Collective Worship is recorded:

- through displays, collections of pupils' contributions, prayers, reflections, photographs, videos etc.

Monitoring and Evaluation

At least once a year the school's provision of worship will be evaluated to consider whether it meets the needs of all pupils and whether pupils are making progress in acquiring skills and abilities in organising and leading worship.

Resources

Resources are stored in each class in the RE area. There is also a central resource in the RE cupboards near the small hall.

Collective Worship is organised in our school as follows:

Monday - Separate KS2 and KS1 & EYFS liturgy with a focus on developing the school's values led by Phase Leaders. KS1 to also celebrate birthdays and new babies.

Tuesday - Class assemblies following a whole school assembly plan.

Wednesday- Infants - Wednesday Word assembly led by Phase Leader with children leading the prayers and music.

Wednesday - Juniors - Hymn Practice

Thursday - Infants - Hymn Practice

Thursday - Juniors - 'Thursday Thought' based on the Wednesday Word. Junior classes take it in turns to lead the assembly with children being directly involved with planning and delivering the liturgy.

Friday - Whole School liturgy with a celebration of special school achievements led by the Head Teacher or Deputy Head Teacher

Friday - The school chaplain to lead a year group or whole school Mass with parents invited.

Voluntary Worship

- Devotions before school for children and their families during October, Advent, Lent and May.

Eucharist

Eucharistic celebrations in school will highlight a special occasion and will normally be celebrated with all children. The same general principles will apply to planning a Eucharistic celebration as other acts of school worship, therefore opportunities for children to participate will be maximised.

We believe that children are best introduced to prayer, the sacraments and particularly the Eucharist in a step by step approach.

Mass is held every Friday at St Mary's as well as on Holy Days. Each year group takes it in turn to plan their own special Mass each term to which parents and the local community are invited. We have a whole school Mass to mark the beginning and end of each term.

Policy Monitoring and Review

This policy is monitored by the RE leader and is evaluated and reviewed by the whole school staff and governors every three years. The Foundation Governors in particular will play a most important role.
