# Privacy Notice (How we use personal information)

St Bernadette's Catholic Primary School is the data controller for governor information.

# The categories of governor information that we process include:

- personal identifiers, contacts and characteristics (such as name, date of birth, contact details and address)
- governance details (such as role, start and end dates and governor ID)
- DBS information
- Personal Development

# Why we collect and use governor information

The personal data collected is essential, in order for the school to fulfil their official functions and meet legal requirements.

We collect and use governor information, for the following purposes:

a) to meet the statutory duties placed upon us, this is a legal obligation.

All maintained school governing bodies, under <u>section 538 of the Education Act 1996</u> and academy trusts, under the <u>Academies Financial Handbook</u> have a legal duty to provide the governance information as detailed above.

# **Collecting governor information**

We collect personal information via

- Nomination forms (Foundation Governors only)
- Parental ballot (Parent Governors only)
- Register of business interests
- Skills Audit
- Governor contact forms
- Inventry signing in system

Governor data is essential for the school's operational use. Whilst the majority of personal information you provide to us is mandatory, some of it may be requested on a voluntary basis. In order to comply with GDPR, we will inform you at the point of collection, whether you are required to provide certain information to us or if you have a choice in this.

## Storing governor information

We hold data securely for the set amount of time shown in our data retention schedule. For more information on our data retention schedule and how we keep your data safe, please visit stbernadette.schudio.com

Data is stored securely in school. Data retention documents are held in a secure location within school and are documented within the archive log.

#### Who we share governor information with

We routinely share this information with:

- our local authority (where applicable)
- the Department for Education (DfE)
- NGA (National Governor's Association)
- Diocese
- Governor Hub
- School Website

#### Why we share governor information

We do not share information about our governors with anyone without consent unless the law and our policies allow us to do so.

#### Local authority

We are required to share information about our governors with our local authority (LA) under our service level agreement with Governor Services.

#### **Department for Education**

The Department for Education (DfE) collects personal data from educational settings and local authorities. We are required to share information about our governors with the Department for Education (DfE), under section 538 of the Education Act 1996

All data is entered manually on the GIAS (getting information about schools), system and held by DfE under a combination of software and hardware controls which meet the current government security policy framework.

#### Requesting access to your personal data

Under data protection legislation, you have the right to request access to information about you that we hold. To make a request for your personal information, contact Nicola Wells at the school office.

Under certain circumstances you also have the right to:

- object to processing of personal data that is likely to cause, or is causing, damage or distress
- prevent processing for the purpose of direct marketing
- object to decisions being taken by automated means
- in certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed; and
- a right to seek redress, either through the ICO, (Information Commissioner's Office), or through the courts

- will increase the transparency of governance arrangements
- will enable schools and the department to identify more quickly and accurately individuals who are involved in governance and who govern in more than one context
- allows the department to be able to uniquely identify an individual and in a small number of cases conduct checks to confirm their suitability for this important and influential role
