Applying for school places

12 September 2026 to 31 October 2026 parents apply for school places.

Parents have between the above dates to state their preferences for their preferred schools.

Children who have an Education Health Care Plan are not to apply to the school admissions team. The parent must contact Wigan Council SEND team and apply directly to them via SENDSadmin@wigan.gov.uk

Online applications

The online application service will open 12 September 2026. There is a link available from the Wigan Council website on the Secondary School admissions page. Parents applying using the Wigan Council Secondary School paper application form

Parents are instructed to return their paper application form to **any** Wigan school. **The form includes a receipt, which is located at the bottom of page 5.**

When a parent returns their application schools **must:**

- Issue parents with the tear off receipt on the bottom of page 5 (parents will keep this as proof of submitting an application)
- Record receipt of the application and record the child's name, date of birth and date received.
- Send the application forms to the School Organisation Team via email admissiontosecondaryschool@wigan.gov.uk or post.

Supplementary information forms

The 'Applying for a place at Secondary School 2027/28' booklet strongly advises parents to complete a supplementary information form for each voluntary aided school they name as a preference on their application form and return it to the individual school by the closing date **31 October 2026.**

Parents can get a copy of a school's supplementary form:

- Directly from the school
- By downloading a copy from the school's website

A voluntary aided school may wish to include their own supplementary information form in any information packs to parents.

Parents are intrusted to return complete supplementary information forms to the school. Any supplementary forms sent to the LA will be forwarded to the school by email and post.

Reminder letters to parents

The LA will write to those address we hold for current Y6 children towards the end of September to remind parents of the closing date.

Please note: the letters will be sent to all addresses the LA hold for children due to start secondary school, this may include those who have already applied. The letter will say 'if you have already applied or you do not have a child due to start secondary school, please ignore this letter'.

Closing date for applications

Parents must return their application form or apply online by the closing date, **31 October 2026**.

The online application service will remain open until the closing date. Applications received at schools or via the online service up to the closing date are classed as on time applications.

As detailed in the secondary co-ordinated admissions scheme on time applications will be considered before any late applications or changes of preferences after the closing date.

1 November to 21 November 2026

LA collated data for all applicants received by the closing date. We will co-ordinate with our neighbouring LA's regarding preferences for Wigan schools from parents who live in other authority areas.

Where there are any duplicate applications or other queries etc, the School Organisation Team will contact the schools concerned.

Ranking lists (own admission authority schools)

Voluntary Aided School

On **15 December 2026** we will provide each VA primary school with a spreadsheet (by email) giving details of pupils who have expressed a preference for a place at their school by the closing date for applications. This list will include preference from parents who live in Wigan and other local authorities.

The spreadsheet will include:

- Child's chosen name and legal name
- Date of birth
- Child's home address (on the closing date for applications)
- Indicate where the **parent has declared** there is a sibling link (this is not verification from the LA)
- Distance from the child's home address to the school (as a straight line distance)
- Details of if a child has an Educational Health and Care Plan where the SEND team have indicated at this stage that school will be named
- If a child is looked after or previously looked after

- A black column entitled 'criterion' where the school can enter details as to the criterion for each applicant.
- A black column entitled 'rank' where the school enters the rank number given to the application.

15 December 2026 to 15 January 2027

- Schools match LA application list with VA supplementary information forms
- Where a child's details appear on the LA list, but parents have not submitted a VA supplementary information form Governors will rank based on the information provided by the LA.
- Governors to rank applications according to their published admission criteria and enter the criterion each applicant has been placed into the 'criterion' column on the spreadsheet.
- Governors to sort the ranking list by criterion then their tiebreaker as published in their admission arrangements. And enter a rank number for each applicant in column 'Rank'.

By **15 January 2027** schools must return the spreadsheet electronically to admissiontosecondaryschool@wigan.gov.uk with details of the criterion and rank number for each application.

During this period of match applications and ranking of preferences is it anticipated that there will be queries. Please do not hesitate to contact the School Organisation Team at admissiontosecondaryschool@wigan.gov.uk to resolve any issues.

Supplementary information form returned but name not on the LA list.

Where a parent has returned a VA supplementary information form but has not expressed a preference for the school on their Wigan Council Application please check with the School Organisation Team.

If parents have not submitted an application form stating a preference for the school by the closing date, **31 October 2026**, the child's name cannot be added to the ranking list. The information should be used when considering late applications and waiting lists.

Other Own Admission Authority Schools (non-church schools)

On **13 January 2027** we will provide the admission authority (Governors/Academy Trust) with a ranked list of applications in accordance with the school's published admission arrangements. This list will include all on time preferences from parents who live in Wigan and other local authorities.

By **20 January 2027** schools must contact admissiontosecondaryschool@wigan.gov.uk confirming that the rankings

have been approved by the admission authority (Governors/Academy Trust).

Resolving of offers

Between 21 January 2026 and 26 February 2027, we (LA) will co-ordinate and resolve offers for applications in line with the equal preference system ensuring each child is offered a place at the highest preference school that can offer a place.

Sometime Wigan pupils cannot be offered a place at any of their preferred schools by there may be alternative places available at other local schools. In accordance with the co-ordinated admission scheme the LA will offer a Wigan pupil a place at the nearest school wo the child's home with a vacancy. Children who live outside Wigan LA we be offered a place by their home local authority.

Notifying schools of final allocation list

We intend to send schools an electronic list of all children who are to be allocated a place the week commencing 22 February 2027, providing that co-ordination is complete, and the allocations have been finalised.

Schools will receive their allocation list by 26 February 2027.

National Offer Day

National offer day is 1st March 2027.

On 1 March 2027 we will notify parents who have applied by the closing date of the outcome of their application. If they have applied online, they will receive an email from 9am on 1 March 2027 or they will be able to log into the portal to view their offer. If they have applied using the paper application form, they will receive a letter.

Parents who live in other local authority will be notified by their home authority.

It is assumed acceptance of places allocated, however if a parent wishes to refuse the place offered, they can email schoolplaces@wigan.gov.uk

The right of appeal

Where a child has not been offered a place at their preferred school, parents have the right of appeal to an independent appeal panel. The refusal letter to parents will explain why a place at the preferred school could not be offered and how they can appeal.

The closing date for the initial round of appeals is **13 April 2027**.

Waiting lists

All schools are required to operate a waiting list for those applications that have been refused a place until the end of the Autumn Term, 31 December 2027. The School Organisation Team will work closely with schools to administer the waiting lists should places become available.

It is vital that the School Organisation Team is informed of any places which may need to be re-allocated as we are responsible for co-ordination the admissions process and making offers during the main admission round.

Community Schools

The Local Authority, as admission authority for Community and Voluntary Controlled schools, will operate a waiting list for places that become available at the schools, until the end of the Autumn Term, 31 December 2027.

Foundation and Academy Schools (non-church schools)

We (LA) will operate a waiting list on behalf of the admission authority for places that become available until the end of the Autumn Term, 31 December 2027 (as described in the 'Applying for a Year 7 place 2027/28' booklet).

Voluntary Aided Schools

We (LA) will send a list of applicants refused places at your school to help you start your waiting list. The waiting list must be kept in the school's oversubscription criteria order as detailed in their admission arrangements. Schools must notify the School Organisation Team when places become available and share a copy of their current waiting list.

Changes of preference and late applications

All applications forms or changes of preference received after the closing date, 31 October 2026 will be classed as late applications (this included any changes of address after the closing date).

If you receive any late applications please:

- Issue a receipt marked with 'late application' and the date received

- Write 'late application' on the top of the form and the date received (preferably a school date stamp) then forward the application to the School Organisation Team

In line with the co-ordinated admission scheme the LA will liaise closely with schools up to and after the allocation date to deal with any late applications or changes of preference. We will provide schools with updated pupil lists periodically up until the end of the summer term as and when required.

Admission Transfer File (ATF)

Following the main round of appeals the LA will send schools a copy of their ATF by uploading it to the S2S DfE system (School to school). This is normally the end of June beginning of July.

Final allocation list (August)

In August 2027, the School Organisation Team will provide you with a list of pupils who are expected to take up the place in Y7 for 2027. These are the pupils who you will need to put on your school roll from the expected date of admission (1st day of term) in line with the Pupil Registration Regulations.
