Part A: Pupil premium strategy plan

Statement of intent

As a school we have lower than average numbers of pupils who receive Free school meals and therefore bring pupil premium finding into the school budget. The needs of these children differ within the school. While the national picture shows that there is a gap in attainment between children on Free School meals and those not on free school meals, this does not apply to all children in Stoke Prior School.

The main barriers faced by eligible pupil can be:

- Limited expressive and receptive vocabulary.
- Limited reading, writing and mathematics skills.
- Limited confidence and self-esteem.

For this reason we have decided to make a difference for these children in two ways.

1. Raise Attainment

The Sutton Trust Toolkit for strategies to improve learning document details the pupil premium intentions of raising achievement of the most disadvantaged pupils.

By reducing class sizes in the school we are committed to raising the achievement of the most disadvantaged pupils. We believe that the biggest effect of reducing class sizes is that pupils will receive better feedback on their learning. The document above details how research has found this to be the most cost effective way of improving learning outcomes for children. We also recognise that this approach benefits all children regardless of ability. It is for this reason that we feel that it a good use of our Pupil Premium funding. As stated above our pupils do not necessarily match the national picture in terms of educational achievement so this approach can be a good use of spending. For the academic year 2020/21 and onwards we have committed additional funding way beyond what we have received for Pupil Premium funding to employ additional teaching staff to reduce class sizes. We have now moved to four full time classes.

The governors this year will ensure that resources are used to support pupils in mathematics and writing as this is where the biggest attainment gap now is. Over

the last few years the attainment gap has narrowed for reading and writing for disadvantaged children. During 2020/21 this gap widened and although the gap narrowed in 2022 in reading the school development plan for 2022/23 details additional resources and engagement with the National Tutoring programme.

2. Curriculum Enrichment

The Sutton Trust Toolkit for Strategies to improve learning also details the pupil premium's wider aims.

- To increase social mobility;
- to enable more pupils from disadvantaged backgrounds to get to the top Universities;
- To reduce the attainment gap between the highest and lowest achieving pupils nationally.

In light of the first and second bullet point it is felt that curriculum enrichment is a prudent way of increasing social mobility and raising aspirations among our disadvantaged young people. During the academic year 2022/23 the school has committed funding to curriculum. We also run a range after school clubs for all pupils (free). We will welcome visiting authors and story tellers and trips to see authors and the Hay Festival. (£1500)

The school is also committed to enriching the curriculum with school visits and visitors. Parents of children who are in receipt of Free school meals have their contributions paid for by the school. We project the cost of this to be approximately £1100 over the year. We also fund the Year 5 and 6 Residential Trip to Condover Hall. (this takes place every two years and last went ahead in Spring term 2022)

Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2021 to 2022 academic year and in previous years.

Impact assessment (related to academic support and Teaching)

This use of Pupil premium has been committed for the past 7 academic years in the same way. During this time period the progress of pupils entitled to pupil premium funding has been closely monitored. Over a number of years both attainment and progress for this group of children has been good.

In Summer 2017 progress of children entitled to pupil premium was monitored. A Large majority of the children within this group made good progress.

In Key Stage 2 100% of Pupil premium children achieved the expected standard in reading, writing and maths. The average progress score for this group was +5.5.

This is well above national figures.

In 2018 Progress scores were again above average. Also in 2018 the attainment gap for Pupil premium children was reduced further in writing and Maths.

In 2019 the attainment gap between Disadvantaged children and all children was reduced in Reading, Writing and Maths.

In 2020 assessment was limited due to Coronavirus however it was clear that reduced class sizes had a positive impact on progress.

In 2021 assessment data showed that the narrowing attainment gap in core subjects had widened slightly. Plans are in place to support all pupils as we have more consistent schooling this year.

In 2022 school data showed that while the attainment gap in reading had narrowed last year the attainment gap in writing and maths remained similar to 2021

Impact related to curriculum enrichment.

The opportunities offered here greatly add to building self-esteem.

The management team will continue to assess the impact of these initiatives through our self-evaluation.

Recovery Premium Funding

Children from Years 3, 4, 5 and 6 will be targeted for tutoring through the National Tutoring Programme during the Autumn and Spring term. 23 children will receive 15 hours of additional Mathematics tutoring. This includes all the Pupil Premium children in these year groups. In the Spring and summer term school led tutoring will enable targeted support for Year 5 and 6 children in core subjects.
