Section 10 - Tax Free Childcare

Using Tax-Free Childcare, Universal Credit Childcare & Vouchers

We accept **Tax-Free Childcare** payments, and families can use this scheme to pay for any chargeable childcare sessions or extended day care at our setting. Parents simply make payments to us through their Tax-Free Childcare online account, and we allocate the funds to their child's fees.

We also accept payments from **other childcare voucher providers**, and these can be used in the same way to contribute toward any chargeable sessions.

For families claiming **Universal Credit Childcare**, we are able to provide invoices or receipts as needed so parents can upload them when submitting their claim.

We also welcome children who are attending on a **fully funded basis**, with no additional payments required unless parents choose optional extras such as extended hours or paid activities.
