#### Statement of intent

This policy sets out the framework in which The Orme Academy will ensure that it actively promotes the fundamental British values of democracy, the rule of law, individual liberty and mutual respect and tolerance of those with different faiths and beliefs.

These values are officially taught through the Religious Education (RE) and Personal Social and Health Education (PSHE) curriculum and are further nurtured through the school's 'Empowering Learners for Life' ethos and promotion of spiritual, moral, social and cultural (SMSC) understanding.

## 1. Legal framework

- 1.1. This policy will have consideration for the following guidance:

# 2. Roles and responsibilities

- 2.1. The Orme Academy understands the importance of promoting British values through a comprehensive and unprejudiced curriculum.
- 2.2. The Principal will ensure that all teachers and staff are aware of the requirement to uphold British values through the methods outlined in this policy, and will ensure that the appropriate procedures are in place to carry out these methods.
- 2.3. Teachers and support staff will ensure that their lessons are inclusive of, and sensitive to, the fundamental British values.
- 2.4. Students are expected to treat each other and staff with respect, in line with the Academy's Behaviour Policy.

## 3. Aims and objectives

Through our policy and procedures, we aim to ensure that our students have:

- An understanding of how citizens can influence decision-making through the democratic process.
- An appreciation that living under the rule of law protects individual citizens and is essential for their wellbeing and safety.
- An understanding that there is a separation of power between the executive and the judiciary, and that while some public bodies, such as the police and the army, can be held to account through Parliament, others such as the courts maintain independence.
- An understanding that the freedom to hold other faiths and beliefs is protected in law.
- An acceptance that people having different faiths or beliefs to oneself (or having none) should be accepted and tolerated, and should not be the cause of prejudicial or discriminatory behaviour.
- An understanding of the importance of identifying and combatting discrimination.

## 4. Democracy

- 4.1. At The Orme Academy students have numerous opportunities to have their views heard through student voice and the student-elected School Council.
- 4.2. Our students are encouraged to have an input into what and how they learn to instil an understanding of democracy for their future.

#### 5. The rule of law

- 5.1. The Orme Academy has a high regard for the laws that govern and protect us, the responsibilities that this involves and the consequences when laws are broken.
- 5.2. At The Orme Academy students are taught these values and the reasons behind laws, whether they govern the class, the school or the country, that are essential for their well-being and safety. Students are allowed healthy debate in class on the matter to encourage recognition of the importance of the law.
- 5.3. The Orme Academy organises visits from authorities throughout the academic year in an effort to reinforce the reality and importance of this message.

# 6. Individual liberty

- 6.1. At The Orme Academy we foster a safe and supportive environment where students are actively encouraged to make choices. Whether it is choosing a challenging task or an extra-curricular club, students have the freedom to base their choices on their interests.
- 6.2. Students are taught about their rights and personal freedoms and are encouraged and advised on how to exercise these safely, for instance through our teaching on e-safety and PSHE lessons.

## 7. Mutual respect

- 7.1. Respect forms a core pillar of The Orme Academy's ethos. Students are treated with respect and learn to treat each other and staff with respect.
- 7.2. This is reinforced through our Behaviour Policy and posters throughout the school promoting mutual respect and the encouragement for our students to be 'Ready, Respectful and safe'.

# 8. Tolerance of those of different faiths and beliefs

- 8.1. The Orme Academy acknowledges that tolerance is achieved through students' knowledge and understanding of their place in a culturally diverse society and the opportunity for students to experience such diversity.
- 8.2. Throughout the year, assemblies are delivered and lessons are taught which focus on bullying, with reference to prejudice based bullying, and discussion is encouraged. The Academy has implemented the Votes For Schools tutorial programme which promotes discussion of some of these key issues.
- 8.3. Tolerance of those of different faiths and beliefs is supported by the RE and PSHE curriculum.
- 8.4. We encourage our students from different faiths or religions to share their knowledge with their peers to enhance their learning.

#### 9. Staff training

- 9.1. At The Orme Academy staff are made aware of their responsibilities in terms of British values during their thorough human resources induction.
- 9.2. Staff will be offered the opportunity for further training on upholding the British Values Policy.

## 10. Review

10.1. This policy will be kept under regular review by the Principal and amended as appropriate to reflect any changes to regulations.
