

		<ul style="list-style-type: none"> <li>• Induction sessions will be held for staff and students as school opens in September 2021 to share all necessary information including health and safety instructions, routines and expectations.</li> <li>• Clear communication has been shared with parents and students (July 2021) with a link on the school website covering all aspects of how school will function from September 2021.</li> <li>• Phone/email communication will be prioritised with parents to limit the number of visitors into school.</li> <li>• Any face to face parental meetings in school will be limited to one member of family where possible and will be by appointment only. 	<b>Use of personal protective equipment (PPE)</b>	<ul style="list-style-type: none"> <li>• Staff working in the testing site will be provided with PPE in accordance with government guidance – see section below.</li> <li>• Designated First Aiders will be supplied with full PPE including a full visor.</li> <li>• If a student becomes unwell with symptoms of coronavirus in school and needs direct personal care until they can return home, a face mask will be worn by the supervising adult. <b>2. Maintain appropriate cleaning regimes, using standard products such as detergents.</b>	<ul style="list-style-type: none"> <li>The school will follow the COVID-19: cleaning of non-healthcare settings guidance: <a href="https://www.gov.uk/government/publications/covid-19-decontamination-in-non-healthcare-settings">https://www.gov.uk/government/publications/covid-19-decontamination-in-non-healthcare-settings</a> and will ensure that this guidance is being implemented by SPIE with all site/cleaning staff.</li> <li>There will be constant communication with cleaning staff about any additional cleaning requirements and additional capacity has been agreed to allow for this.</li> <li>All areas and surfaces will be deep cleaned prior to the full re-opening of the school.</li> <li>All classrooms and areas used by staff and students will be cleaned once they have left the building.</li> <li>Sanitizer stations will be located across the school site.</li> <li>Toilets will be cleaned regularly and the supply of hand soap refilled.</li> <li>Staff will be advised to report any concerns around cleaning to the facilities manager.</li> <li>If there is suspected case of Covid 19 the school will follow the COVID-19: cleaning of non-healthcare settings guidance.</li> </ul>		SLT/DCo  DCo DCo DCo DCo DCo SLT/Staff SLT	
<b>3. Keep occupied spaces well ventilated</b>	<ul style="list-style-type: none"> <li>All spaces will be well ventilated using natural ventilation (opening windows) as far as possible.</li> <li>Doors will be propped open, where safe to do so, to aid ventilation. Staff will be asked to report any estates issues to the facilities manager e.g. doors, windows, immediately so that these can be fixed.</li> <li>Air conditioning units can be turned on as these draw in fresh air from outside.</li> <li>Staff will manage ventilation in classrooms and offices to ensure a comfortable working temperature when rooms are occupied.</li> <li>Staff and students will be advised to wear additional layers of clothing (in accordance with student uniform expectations) in cold weather. 	<p><a href="https://assets.publishing.service.gov.uk/government/uploads/system/uploads/attachment_data/file/964351/Schools_coronavirus_operational_guidance.pdf">https://assets.publishing.service.gov.uk/government/uploads/system/uploads/attachment_data/file/964351/Schools_coronavirus_operational_guidance.pdf</a></p> <ul style="list-style-type: none"> <li>• School will maintain accurate records of any positive cases in order to detect any increases in cases but will no longer be required to submit a data return to the Local Authority for each individual case.</li> <li>• In line with government guidance, from Step 4, potential close contacts will be identified via NHS Test and Trace and school will not undertake contact tracing.</li> <li>• Contacts from a school setting will be traced by NHS Test and Trace where the positive case specifically identifies the individual as being a close contact.</li> <li>• From August 2021 students will no longer be required to self-isolate if they are contacted by NHS Test and Trace as a close contact of a positive COVID-19 case. Instead, they will be advised to take a PCR test. School will encourage all individuals to take a PCR test if advised to do so.</li> <li>• Staff will be made aware that they are not required to self-isolate if they live in the same household as someone with COVID-19, or are a close contact of someone with COVID-19, and any of the following apply: <ul style="list-style-type: none"> <li>○ they are fully vaccinated</li> <li>○ they have taken part in or are currently part of an approved COVID-19 vaccine trial</li> <li>○ they are not able to get vaccinated for medical reasons</li> </ul> </li> <li>• The school will consult with PH Wirral on a case by case basis to seek guidance as required.</li> <li>• Where a positive case is picked up through the school’s LFD test site or home testing, staff/parents will be informed that they should seek a follow-up PCR test, in line with the latest government guidance (July 2021).</li> <li>• The school will utilise the DfE COVID helpline 0800 046 8687 if required to seek further advice.</li> <li>• The school will implement a COVID email address for parents to report positive cases at weekends and during holidays.</li> <li>• A review of school actions will be held following the management of any positive cases to capture “lessons learned” and refine the school response.</li> <li>• Public health messages are reinforced regularly with parents following analysis of positive cases in school.</li> <li>• Whilst awaiting pick-up, any staff/students will be isolated in the designated separate sanitary area (meeting room off main reception) and will be provided with a face-mask. 	<ul style="list-style-type: none"> <li>If a member of staff, likely to be a First Aider, has helped someone who was unwell with coronavirus symptoms, they should wash their hands thoroughly for 20 seconds after any contact. The member of staff may choose to go home if they wish but there is no requirement for them to remain at home unless they develop symptoms themselves or the student or staff member subsequently tests positive. Core areas where the staff or student has been will be deep cleaned.</li> <li>If an outbreak is suspected or there is an overall rise in sickness absence linked to COVID, the school will seek advice from PH Wirral and apply their outbreak indicators, as advised.</li> </ul>		SLT/Staff  SLT
<b>Face coverings</b>	<ul style="list-style-type: none"> <li>In line with government guidance, face coverings will no longer be advised for students, staff and visitors either in classrooms or in communal areas from July 2021. However, staff and students may wish to make a personal choice to continue to wear a face covering in school.</li> <li>Staff and students will be advised that face coverings are also no longer recommended to be worn on dedicated transport to school and are no longer legally required, although remain recommended, on public transport.</li> <li>School will follow Public Health guidance regarding re-introducing face coverings if there is considered to be an outbreak in school – see separate contingency framework plan.</li> <li>In these circumstances, transparent face coverings, which may assist communication with someone who relies on lip reading, clear sound or facial expression to communicate, can also be worn.</li> <li>In these circumstances, face visors or shields can be worn by those exempt from wearing a face covering but they are not an equivalent alternative in terms of source control of virus transmission and will only be used after carrying out a risk assessment for the specific situation and should always be cleaned appropriately.</li> <li>No student will be denied education on the grounds of whether they are, or are not, wearing a face covering.</li> </ul>		SLT  SLT  SLT  SLT  SLT
<b>Testing</b>	<p>The school will operate rapid testing in accordance with government guidelines. <b>Mixing and bubbles</b>	<ul style="list-style-type: none"> <li>• School will implement government guidance at Step 4, which states that it is no longer necessary to keep children in consistent groups ('bubbles').</li> <li>• Assemblies will resume and year groups can mix at break and lunch times, although split lunches are in place.</li> <li>• School will reintroduce 'bubbles' for a temporary period, to reduce mixing between groups, only if directed to do so by Public Health – see contingency framework.</li> <li>• Non-overnight and overnight educational trips and visits will be permitted to take place within the UK or overseas and will have a full risk assessment that incorporates COVID controls to ensure they can be carried out safely.</li> <li>• Internal examinations and assessments will be carried out in the hall with a full seating plan in place, ensuring desks are spaced apart adequately.</li> </ul>		SLT
