- Fostering Allowance
- Employment and Support Allowance Contributory Allowance

Children attending nursery

Children aged below the statutory school age, but attending a state funded nursery school or class are only entitled to free school meals if they receive education both before and after lunch. This will be confirmed with the nursery.

Young people attending college

Young people attending college should make enquiries with college staff regarding eligibility for free meals.

Checking for eligibility for free school meals (FSM)

The criteria for eligibility for FSM are set nationally. The Local Authority verify eligibility with information held by the Dept. of Work and Pensions/Her Majesty's Revenue and Customs as the FSM team does not have access to information about the benefits that applicants receive.

The date that eligibility is confirmed is the date when FSM start and we are unable to back date. Claims are reviewed annually.
