Height and weight checks for children in Reception and Year 6

Every year in England, school children in Reception and Year 6 have their height and weight checked at school as part of the National Child Measurement Programme. Height and weight measurements are used to calculate weight status. We collect this information because it is in the public interest to understand how many children are overweight, healthy weight or underweight. Your child's class will take part in this year's programme.

The checks are carried out by trained Healthy Families Support Workers. Children are measured fully clothed, except for their coats and shoes, in a private space away from other pupils.

Maintaining the well-being of children in the NCMP

The wellbeing of children and families is very important. Measurements are conducted in a sensitive way, in private and away from other children. Individual results are not shared with your child or their school. The weight and height information is shared only with you in the parent or carer feedback letter. It is your choice if you share the information with your child.

The emotional impact of the NCMP has been researched and studies show that body image, self-esteem, weight-related teasing and restrictive eating behaviours do not change as a result of being measured or receiving feedback. If you are concerned about your child's growth, weight, body image or eating patterns, seek further support from a school nurse or General Practitioner.

The information we collect and what it is used for is listed below:

- your child's date of measurement, sex and date of birth are used to calculate your child's weight category
- your child's name, date of birth and NHS Number are used to link your child's measurements in Reception and Year 6. Other data sets held by NHS Digital and Department of Health and Social Care, may also be linked as this would let us add information from health and education records, where lawful to do so, to understand how and why the weight of children is changing, and how this affects children's health and education and how we can improve the care children receive. This includes your child's health data relating to;
 - their birth, hospital care (including time in hospital and out-patient appointments and diagnosis of medical conditions)
 - mental health

- social care
- primary care - includes all healthcare outside of hospital such as GP and dental appointments,
- public health - including data relating to preventing ill health such as immunisation records
- records for when and the reason why people pass away
- medical conditions such as cancer, diabetes
- health, lifestyle and wellbeing surveys that your child has participated in
- Your child's ethnicity and address are used to help understand some of the reasons for the difference and changes in child weight across England
- Your address is required to send you your child's feedback letter. This will include your child's measurements together with information about healthy eating, being active and related activities available in your area.
- your email address and telephone number are required as we may contact you by email or telephone to discuss your child's feedback/ send you your child's feedback letter by email/ offer you further support following your child's height and weight measurement.

All the data collected is also used for improving health, care and services through research and planning.

All information is treated confidentially and held securely. No individual measurements will be given to school staff or other children.

How the data is used?

The information collected from all schools in the area will be gathered together and held securely by Bolton Foundation Trust. We will store your child's information as part of their local child health record on the NHS's child health information database and share it with their GP.

All the information collected about your child will be sent by us to NHS Digital. NHS Digital is responsible for collecting data and information about health and care so that this can be used to monitor and improve the care provided to people across England.

The information collected about your child will also be shared by NHS Digital with the Office for Health Improvement and Disparities (OHID) which is part of the Department of Health and Social Care (DHSC) but in a de-personalised form only. This means OHID will not be able to identify your child. OHID focuses on improving the nation's health so that everyone can expect to live more of life in good health, and on levelling up health disparities to break the link between background and prospects for a healthy life.

Both NHS Digital and the Office for Health Improvement and Disparities (DHSC) will use the information from the National Child Measurement Programme to better understand numbers and trends in child weight and body mass index (BMI). This helps with the planning of services to support healthy lifestyles in your area. No information will ever be published by NHS Digital or the Office for Health Improvement and Disparities (DHSC) that identifies your child.

De-personalised information from the National Child Measurement Programme may also be shared by NHS Digital with other organisations, such as universities. This is to help improve health, care and

services through research and planning. This information cannot be used to identify your child, and NHS Digital only ever shares information for research with the approval of an independent group of experts.

Withdrawing your child from the National Child Measurement Programme

If you are happy for your child to be measured, you do not need to do anything.

If you **do not want** your child's height and weight to be checked, or your child has a medical condition that affects their height or weight please let us know by contacting the Healthy Families Team on 01204 463175 or by emailing HF@boltonft.nhs.uk including your child's details

Children will not be made to take part on the day if they do not want to.

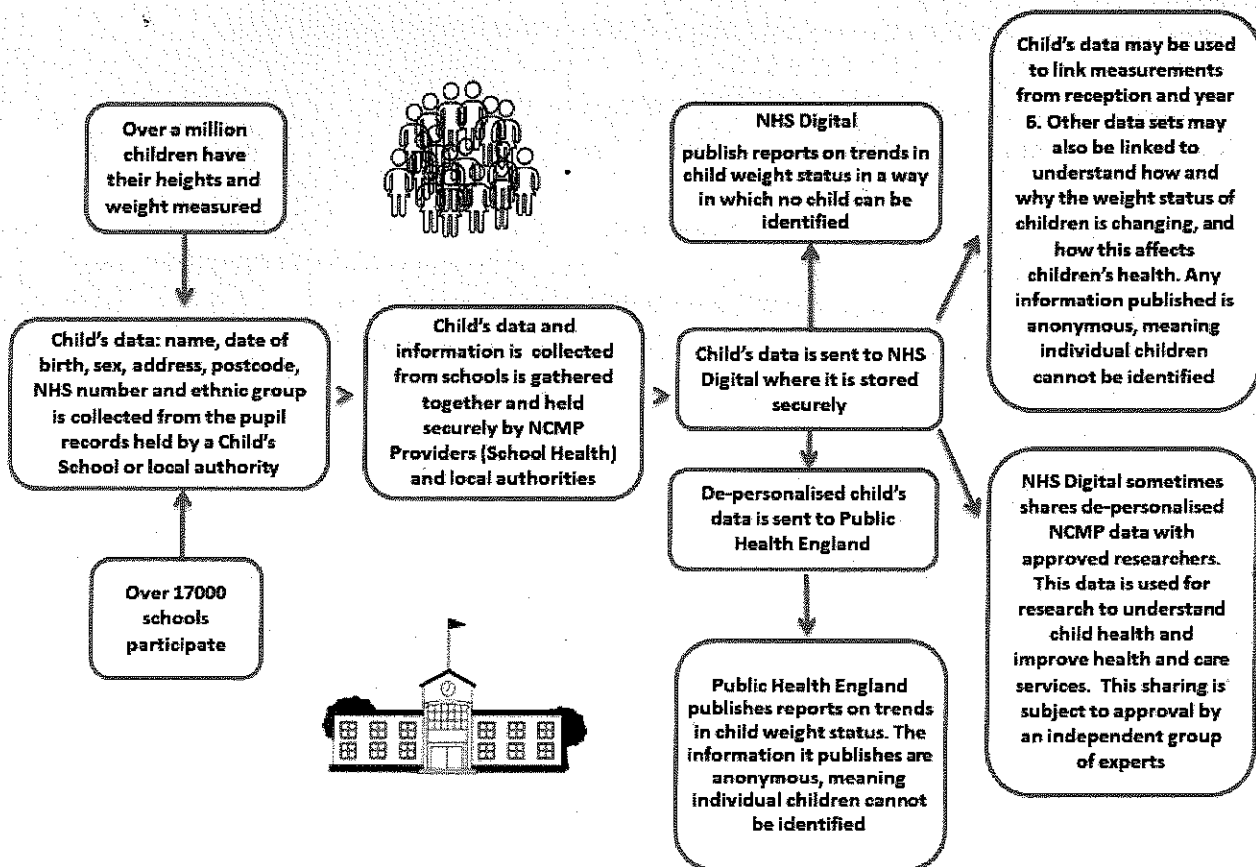

How your child's data is collected and processed as part of the National Child Measurement Programme (NCMP)

Local authorities have a legal duty to collect the NCMP data. They do this by following guidance from Public Health England. Local authorities are responsible for making decisions on how the data is collected and for making sure it is protected. Local NCMP service providers are contracted to carry this out; this might be through the school nursing team working in schools or a local healthcare provider. The team collecting the data enter it into the NCMP IT system, which is provided by NHS Digital. The data may also be entered into a local child health information system. Your local authority is responsible for sending the data to NHS Digital. NHS Digital and Public Health England are jointly responsible for the data held at a national level. Your local authority is responsible for the data held locally.

Consent to Reception NCMP and Vision School Screening Programme

Dear Parent/Guardian

Each year the Healthy Families Team, part of Bolton NHS Foundation Trust delivers the universal primary screening service to every school in Bolton and all reception children receive the NCMP (please see other enclosed letter) and Vision.

Healthy Families Support Workers carry out the screening. The screening will be completed in a suitable room allocated by school and will be screened in groups of no more than 5 children at a time. If your child requires further assessment following the results of the screening this will automatically be generated.

All staff will ensure that they complete a full risk assessment of the school environment they will be working prior to commencing the vision screening.

If you would like to discuss this further, please do not hesitate to contact the Healthy Families' Team. **Please note your child will be screened for vision unless you contact the Healthy Families Team on 01204 463175 to inform us that you wish to withdraw consent.**

After the screening-

We will record your child's results in their records and send you a written copy. We may contact you to discuss with you any results that may need further monitoring.

Statement

As an NHS foundation trust we hold information about your child so that they can receive proper care and treatment. This information is held confidentially and securely. For the Ophthalmological diagnostic and testing. For the vision screening information, we use software to process information on our behalf and this is provided by a third party company. We have ensured that this company is bound by the GDPR and meets the same strict information security requirements and data protection required by the Trust.

We treat all information securely and confidentially in line with the Data Protection Act 1998. Please contact us if you have any concerns about how we use your child's information.

We will be in contact with your child's school to arrange a mutually convenient date to complete the screening. The results will be sent home in your child's bag up to two weeks after the screening has taken place.
