1 Destinations of Year 11 School Leavers in 2022

During the 2021-22 academic year 16 young people attended year 11 at Wandle Valley Academy. 56.3% of these young people progressed into a learning activity, which includes full time education, training and employment with accredited training.


The majority of young people continued in education (56.3%) whilst 25.0% were Working towards participation. 18.8% had moved out of the area or were unable to have their activity ascertained at the time of the survey.

7 (77.8%) of the young people who continued in full time education were studying in another local authority area.



Top 5 Educated Establishments






There has been a decrease in the percentage of young people who have continued in full time education when compared to 2021.



Employment & Training Destinations Over Time




5. Destinations by Ethnicity
