## Subject: External Exam Entries Summer 2025

I am now able to confirm your child's qualification entries for the Summer 2025 series. Please find enclosed your child's **Exam and Non-Examination Assessments (NEA) entry statement** and **timetable** for the summer 2025.

Your child's Statement of Entry shows

- Board timetabled Written exams
- Not Timetabled Non-Examination Assessments (NEA)

Your child's Individual Candidate Timetable shows

• Board timetabled - Written exams detail date, start time, duration in minutes, exam board, qualification level, qualification element and exam paper component

These written exams are the **only days and times they can take place**, so it is vital that your child is in school.

There will be other types of formal exams during the spring and summer term known as **Controlled Assessments, Coursework, and Non-Examination Assessments (NEA).** These will appear on your statement of entry as "Not Timetabled". They do not have a set date and your child will sit them when their teacher thinks it is best during the normal school day.

These examinations both written and NEA are governed by JCQ rules and regulations links provided below. Please take the time to read these with your child to make sure you are both aware of the regulations – especially the *Information for written examinations*. **Any breach** of JCQ Rules and Regulations will result in your child being **disqualified**.
