## Subject: Entry Level Qualification Entries Summer 2025

During this school year your child will be completing **Entry Level Certificate exams known as Non-Exam Assessments**. This is where your child will complete a type of assessment or coursework element based on a scenario or exam paper set by the exam board. These exams **do not always have a set date.** Your child will sit them in class during the normal school day when their teacher thinks they are ready to do so.
